2.3 Recognition of Cinco de Mayo

**WHEREAS** the date May 5, 1862, marks a vital and significant time in the battle for Mexican independence; and

2.5 Resolution Opposing Assembly Bill 2859 Program Improvement Interventions and Sanctions

**WHEREAS** Assembly Bill (AB) 2859 proposes to shift the control for oversight of all Program Improvement (PI) school districts in California; and

**WHEREAS** AB 2859 would remove the role of the State Board and State Superintendent to determine and carry out interventions and sanctions under the No Child Left Behind Act; and

**WHEREAS** AB 2859 would usurp the power of voters to elect their local school board and make the board unaccountable to them by granting appointment powers to the county superintendent of schools under certain conditions; and

**WHEREAS** AB 2859 would grant the county superintendent of schools power to reconstitute a district or appoint an academic administrator to dismiss district employees; and

**WHEREAS** educational research has proven that the key to effective education relies on keeping decision-making close to the classroom and not in far-away administrative or county offices; and

5.2 Board Members' Inservice and Business Expense Report for the Period Beginning July 1, 2005, Through March 31, 2006  
(Prepared by Business Services Division)

5.3 Highland-Cypress II – Evaluation of Proposed School Site  
(Prepared by Facilities/Operations Division)

The Facilities Management Department has been evaluating future school sites and has determined that the Highland-Cypress II proposed elementary school site is no longer needed for the following reasons:

- Elementary enrollment projections for this area have remained relatively the same, with an estimated seven-year projection of a 1.5 percent decrease by year seven.
- Five current elementary school sites are less than two miles from the proposed Highland-Cypress II site, and two additional proposed elementary school sites, Emmerton II and Monterey II, are 2.5 miles or less in distance.

Based on enrollment projections and the proximity of existing and proposed elementary school sites, we recommend that the proposed Highland-Cypress building site be dropped from consideration.

5.4 Acknowledge Receipt of Initial Contract Proposal From the Communications Workers of America (CWA)  
(Prepared by Employee Relations Division)

Section 3547 of the Government Code requires that all initial proposals of exclusive representatives be presented at a public meeting of the public school employer. At that meeting, any interested parties shall have the opportunity to comment on the proposal. Now is the time for such public comment from any interested person or persons.

Article XV, Section 2, of the Collective Bargaining Agreement between the District and the Communications Workers of America (CWA), provides that CWA may submit an initial proposal for renegotiation of two articles for the 2005-2006 school year. On April 10, 2006, the Employee Relations Division received the initial proposal from CWA to bargain over wages and a new article on benefits.

9.3 Payment for Course of Study Activities

District schools find it to be educationally advantageous to employ persons outside of the District in order to provide activities that enhance their educational programs.

Urbita Elementary School wishes to hire Jose-Luis Orozco through Arcoiris Records, Inc., to present “Language, History and Culture through Music” on May 30, 2006. This presentation is a family concert, promoting Spanish language children’s traditions and Latin American culture through music. Mr. Orozco is a children’s author, songwriter, performer, and recording artist. He is a featured speaker and presenter at educational conferences and seminars for teachers, parents, and childcare providers. He participated in the National Book Festival organized by the Library of Congress and was honored there by the Congressional Hispanic Caucus in Washington, D.C. Music Born in America, comprised of performing artists and entertainers, Sandii Castleberry and friends, specializes in Americana roots music and perform folk music assemblies that integrate U.S. history with American folk music. Arroyo Valley High School wishes to hire Richard Santana to present "The Winner Within You" on May 19, 2006. This presentation addresses diversity, self-esteem, education, gang prevention, drug awareness, pregnancy prevention, healthy choices, and resilience. Mr. Santana uses his background as a third generation gang member, who went on to earn a Master's degree from Harvard University, to demonstrate the change that occurred in his life, and can occur in anyone's life. He arrives on stage with trademark gang clothing, baggy pants, shades, trench coat, and red bandana, which he later sheds to reveal himself dressed in a suit and tie, as a college graduate, educator, counselor, colleague, and friend. The cost, not to exceed \$2,400.00, will be paid from Arroyo Valley High School Account No. 453.

Parkside Elementary School wishes to hire Darrell Funn, through Funnsquad, to present a "Funn Basketball Clinic" on May 24, 2006. This presentation promotes physical and mental conditioning, and skills development. Participants will learn basketball skills, good sportsmanship, and teamwork concepts. Funnsquad has experienced trainers that participate in college, high school, and local youth center activities. The staff has over 20 years experience in dealing with youth of all ages. 9.6 Federal/State/Local District Budgets and Revisions  
(Prepared by Business Services Division)

Throughout the year, the District is advised by federal, state, and local agencies of program entitlements and any additions and/or reductions in funds available for already approved programs. The following programs requested by the Board of Education affect the restricted and unrestricted portions in the budgets of the District funds. In order to adjust the program budgets, it is necessary to have Board of Education approval.

The restricted School Health Index Program (319) was not included in the 2005-2006 approved budget. Based on the grant award letter received from Center Disease Control Foundation on April 10, 2006, an increase in the amount of \$9,910.00 will result in a revised total of \$9,910.00.

The restricted CDBG Anderson Program (326) was not included in the 2005-2006 approved budget. Based on the contract extension letter received from the county on April 11, 2006, an increase in the amount of \$408.00 will result in a revised total of \$408.00.

The restricted Targeted Instructional Improvement Grants Program (610) was included in the 2005-2006 budget in the amount of \$9,110,018.00 in expenditures. The difference of \$9,110,018.00 is funded from carryover of prior year fund balance. Based on the Notice of the Final Apportionment received from California Department of Education on April 10, 2006, an increase in the amount of \$1,244,452.00 will result in a revised total of \$1,244,452.00 for revenue and \$10,354,470.00 for expenditures.

It is recommended that the following resolution be adopted:
