On September 19, 2006, the Board approved an agreement with RAN Enterprises, Inc., Huntington Beach, CA, as one of the contractors for the new construction at Bing Wong Elementary School, Bid No. F05-18, Category 17 - HVAC. The original contract amount was for \$878,000.00 with change orders bringing the total to \$955,417.97.

A dispute arose over a claim submitted by RAN in the amount of \$314,318.18, due to potential delays and shop drawings approved by the Architect. The delays were caused by work stoppage mandated by the Division of State Architect due to defective China-manufactured structural steel. This delay resulted in the District's exposure to the claims asserted by RAN. The District and RAN have reached a settlement agreement in the amount of \$70,000.00. This amount is the full and final satisfaction of the claim. The cost will be paid from Fund 35.

It is recommended that the following resolution be adopted:

Principals are required by Education Code to report guns, brandishing a knife, sexual assault, possession of an explosive device, and/or the sale of an illegal substance. 9.32 <u>Petition to Expunge, Rescind, or Modify Expulsion</u> (Prepared by Youth Services Department)

Education Code 48917, Section (e) states: upon satisfactory completion of the rehabilitation assignment of a pupil, the governing board shall reinstate the pupil in a school of the district and may also order the expungement of any or all records of the expulsion proceedings.

9.33 <u>Education Code 48213</u> (Prepared by Youth Services Department)

Education Code 48213 states: that a student can be excluded from attendance pursuant to Section 120230 of the Health and Safety Code or Section 49451 of this code if a principal or his designee determines that the continued presence of the child would constitute a clear and present danger to the life, safety, and health of a pupil or school personnel. The governing board is not required to send prior notice of the exclusion to the parent or guardian of the pupil. The governing board shall send a notice of the exclusion as soon as is reasonably possible after the exclusion.

9.34 Request for Waiver of California High School Exit Exam (CAHSEE) Passage Requirement for Students with a Disability (Prepared by Research & Technology)

Education Code Section 60851(a) provides that "Commencing with the 2003-04 school year and each school year thereafter, each pupil completing Grade 12 shall successfully pass the exit

examination as a condition of receiving a diploma of graduation or a condition of graduation from high school." Waiver of the successful passage of the CAHSEE is allowed under Specific Code Section: E.C. 56101: "...the waiver is necessary or beneficial to the content and the implementation of the pupil's individualized education program..." Waiver of the successful passage of the California High School Exit Exam (CAHSEE) is requested for the specific students with the birthdates listed below:
