## **Clarkstown Police and Clarkstown Central School District**

Institutionalized, Long-Standing Partnership with Clarkstown Police Dept. (CPD)

- Town Supervisor George Hoehmann and Chief Jeff Wanamaker actively engage in ongoing safety planning, resource allocation and actions.
- "Omnipresence" Patrol officers make elementary school stops as part of the daily tour of duty and park patrol cars in school parking lots
- Partnerships on threat assessments and investigations. Student safety checks.
- Assist in the communication process during emergencies
- Guidance and support for schools on safety drills and plans
- Traffic, security consulting and staffing at CCSD events
- CPD patrol cars have key card ID badges to enable entry to all schools
- CPD patrol cars have interior and exterior maps of all schools
- D.A.R.E Program Grade 5
- Six School Resource Officers (SROs)

# **Prevention and Response - Staff and Students**

- Each building and the District have a safety team and emergency response plan which is updated annually.
- District Safety Team provides resources and support to buildings during school emergencies.
- Students and staff complete a minimum of 12 drills a year, including four lockdown drills
- Annual fire, risk management and playground inspections



#### **Lead Testing**

- NYS regulation Test drinking water in schools for lead contamination.
- 15 parts per billion (ppb) threshold
- Tested in 2016 and in 2021
- CCSD water supplier SUEZ Water, supplier to most homes in the community
- Testing results
  - 1.078 water sources tested
  - 980 passed, 98 sources exceeded 15 ppb
  - Corrective actions have been taken. Retesting scheduled
  - Minimal risk Water fountains have been off-line
  - Faucets for handwashing only. Signage in place
- Next step Testing of water fountains
  - Off-line due to COVID
  - DOH requires water sources to be in normal operation for testing



#### Phase 3 and 4 Projects Completed - Safety Related

- Phase 3 (Summer 2019) Roofs and Transformers
- Phase 4 (Summer 2020) Turf fields, tennis courts; FFMS drainage, storefront and lighting



#### **Heating / Ventilation**

(Summer/Fall 2020) Study unit ventilator project, HEPA filter installation, reengineer facilities to prepare for hybrid instruction

- Heating systems are on-line and are monitored
- Ventilation systems continue to provide fresh air to all occupied spaces
- HEPA air purifiers in all occupied spaces continue to operate effectively
- HEPA filters have been replaced
- AHU/Univent filters have been replaced



#### **Phase 5 Projects - Safety Related**

- Playgrounds New equipment, designed to current safety standards
- FFMS Sidewalks/Paving address broken / uneven walking surfaces
- Birchwood gym floor replacement addresses old vinyl asbestos tile
- SHS weight room AC addresses temperature/humidity to address health concerns of strenuous activity in an enclosed area
- NHS New modified campus entrance to allow for better traffic / pedestrian circulation and enhanced security



# **Safety at School Sporting Events**

- Anyone experiencing COVID symptoms is expected to remain at home.
- All spectators are asked to socially distance between different household units and follow public health guidelines.
- We encourage spectators to be actively involved in positive behaviors that promote support for our team. Discourteous or unsportsmanlike behaviors are unacceptable and will be immediately addressed by game security staff.
- Section One Athletics prohibits the use of sound producing devices at interscholastic games (horns, whistles, etc).
- Children under the age of 14 must be accompanied by a parent or guardian to attend football games at both Clarkstown High Schools North and South.
- Festa students must be accompanied by an adult or be participating in a supervised activity to remain on the school grounds.
- Bags are not allowed. Also, beverages purchased from outside the stadium are not allowed.

#### Department of Health Mandatory Mask Wearing.

Effective August 27, 2021 and in accordance with the Commissioner's Determination issued pursuant to the New York State Department of Health 10 NYCRR 2.60:

any person over the age of 2 (including all students, personnel, teachers, administrators, contractors, and visitors) must wear masks at all times indoors in P-12 school buildings, regardless of vaccination status.
