The summary will be read instead of the entire message in the event that there is a large number of comments and reading each of them in their entirety would extend beyond the time allotted for public comment. **Public input must be submitted by 1 pm on Tuesday, the day of the regularly scheduled Board of Education meeting, to allow for the organization of materials.***

**In an effort to allow more input to be heard, we ask that public comments be limited to no more than 1 minute in length.**
