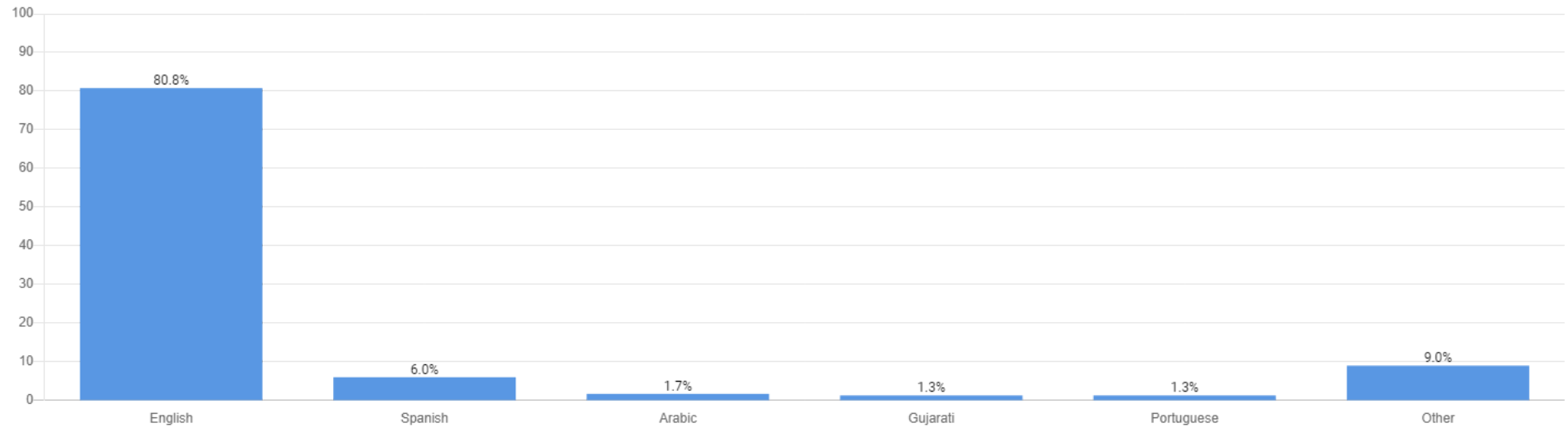

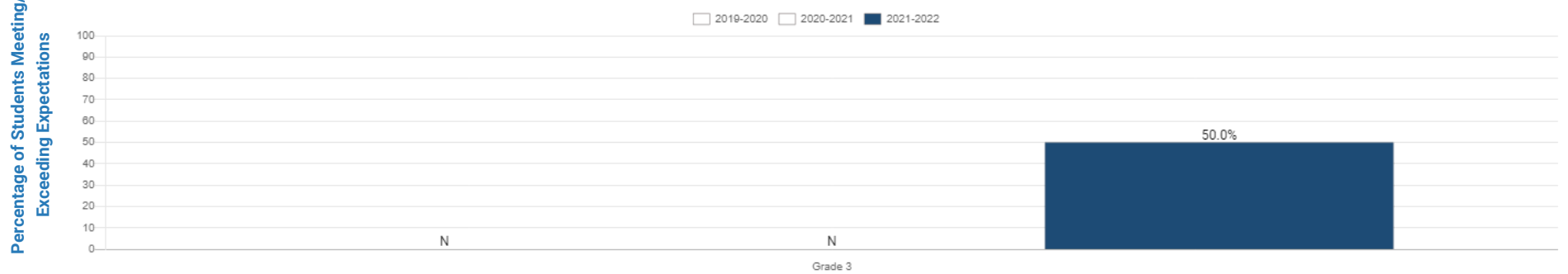

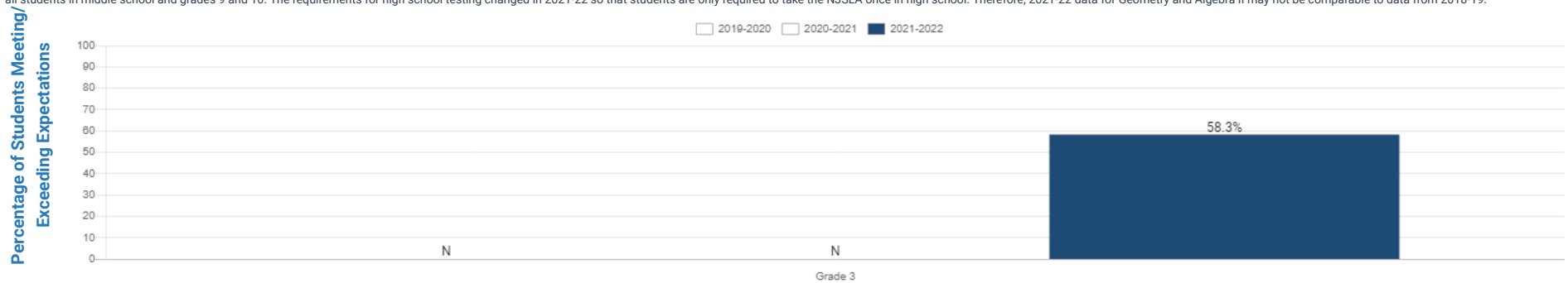

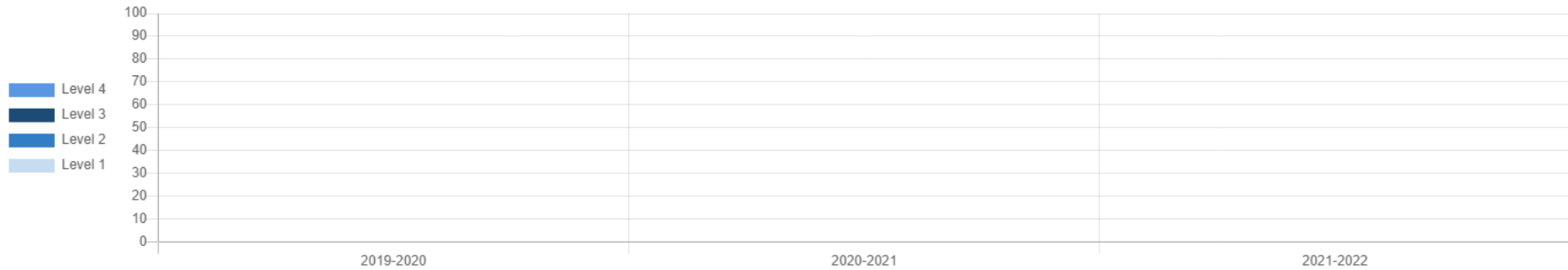

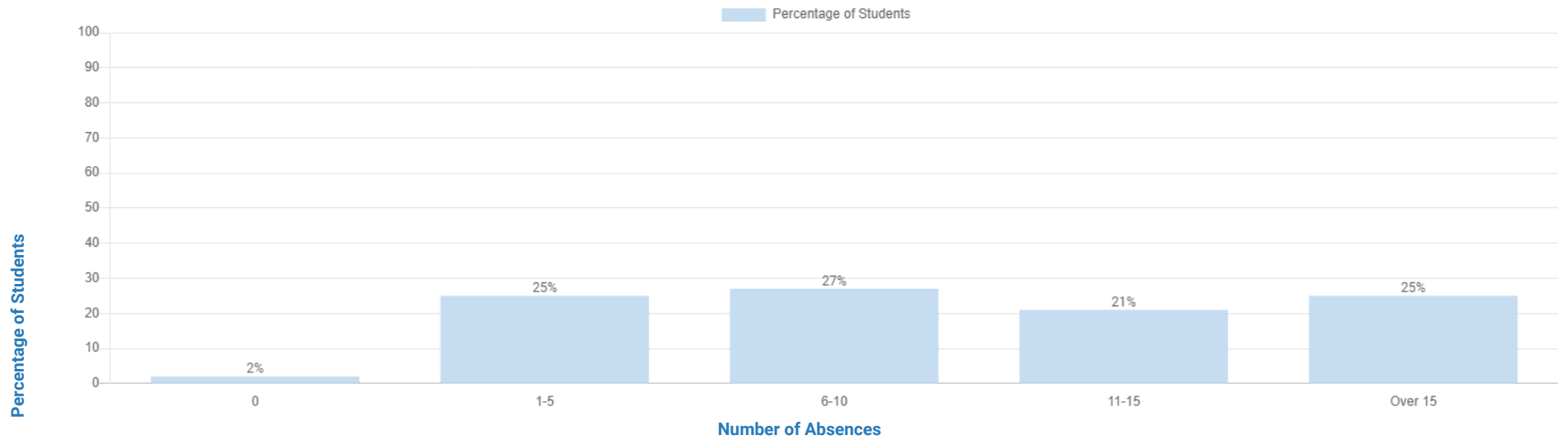

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.



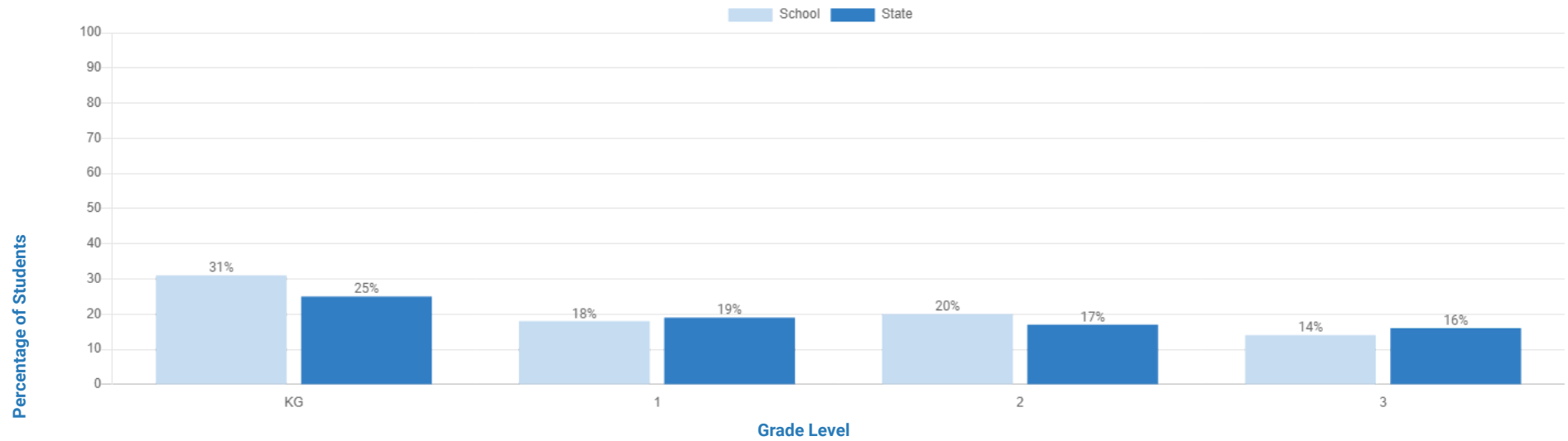

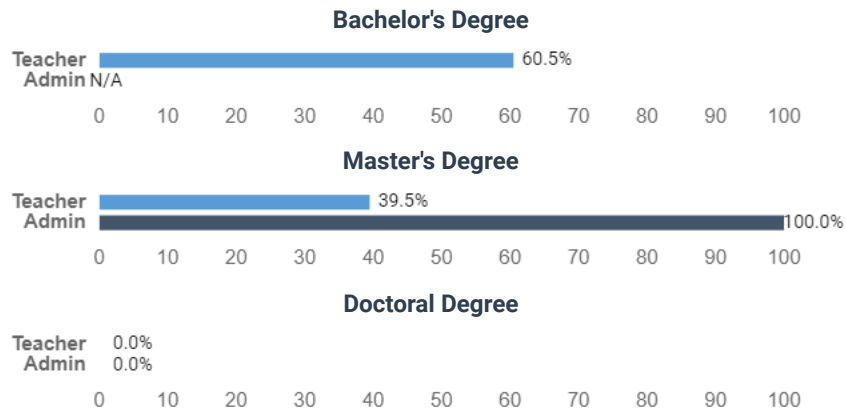

Accountability

New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools that are in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
 - Schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
 - High schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
 - Schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
 - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e. ATSI schools that do not meet exit criteria.
 - The NJDOE has not yet identified schools in this category as no ATSI schools have been in status for three or more years.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
 - Schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

Important Note for 2021-2022: Due to the COVID-19 pandemic, New Jersey received waivers from the United States Department of Education (USED) in both [March 2020](#) and [March 2021](#) that waived accountability-related requirements in the Elementary and Secondary Education Act (ESEA) for the 2019-2020 and 2020-2021 school years. These waivers removed the requirements to:

- Calculate indicator scores and summative scores for the 2019-2020 and 2020-2021 school years;
- Measure progress toward long-term goals and measures of interim progress for accountability indicators for the 2019-2020 and 2020-2021 school years; and
- Identify schools for comprehensive and targeted support and improvement during the 2020-2021 and 2021-2022 school years (based on 2019-2020 and 2020-2021 data, respectively).

As a result of these waivers, any school that was identified for comprehensive or targeted support and improvement during the 2019-20 school year will retain the same status for the 2021-22 and 2022-23 school years.

The NJDOE identified schools across four categories during the 2022-23 school year (based on 2021-22 data):

- CSI: Overall Low Performing;
- CSI: Low Graduation Rate;
- ATSI; and
- TSI.

For the TSI identification that occurred during the 2022-23 school year, status in meeting annual targets for the 2018-19 and 2021-22 school years were used since data was not available for two consecutive years.

Additionally, all schools that were previously identified were eligible to exit status at the end of the 2022-23 school year if the NJDOE's Exit Criteria were met.

The NJDOE received approval to make a one-time change to the identification timeline under the COVID-19 State Plan Addendum. Under the approved Addendum, the NJDOE will identify schools for CSI and ATSI status in both fall 2022 and fall 2023. Schools identified for CSI or ATSI status in fall 2022 will be eligible to exit status in fall 2023 if all exit criteria are met. Schools identified for TSI status will be eligible to exit annually if exit criteria are met.

The growth measure used for 2021-22 is an alternate measure used because median student growth percentiles were not available for 2021-22. Highlights:

- We continue to implement the Fountas & Pinnell Classroom program to enhance and improve literacy skills. Writing components have also been added to offer a more comprehensive and cohesive program.
- Our Response to Intervention program involves tier 2 supplemental small group instruction and morning literacy and math academies. Tier 3 intervention services include one to one instruction.
- The Stars Program, funded by the PTO and taught by teachers, offers students the opportunity to participate in enrichment activities such as STEM class, soccer, and basketball.



Mission, Vision, Theme:

Dwight D. Eisenhower Elementary School is working in conjunction with the district to meet the district Vision 2030 which is committed to the holistic development of all our students in order to provide them with specific skill sets, character traits, and values that they will need to become successful in a competitive global workforce now and up to year 2030.

Students in need of more intensive interventions receive one to one Project Read instruction.

Before and After School Programs:

Our school and district has a partnership with Leading Edge Education which runs before and after school programs. The program provides homework help, academic support, character building programs and socialization skills. The program is supported by the company's unique curricula.



Staff and Professional Learning:

Currently, our teachers are developing their skills and receiving training on our new reading system through Fountas and Pinnell. Our teachers also worked, through a partnership with Teacher 2 Teacher, with a reading expert to coach our kindergarten through third grade teachers on best practices and strategies for improving our students' literacy skills. Staff is also receiving ongoing training on the implementation of Responsive Classroom.



Student Supports and Services:

Our students are provided with the following services, if needed: ELL instruction, pull out replacement instruction, and/or in-class support instruction for our special education population. NJTSS is provided for all of our struggling students. Our students also have a weekly visit from the school counselor, who spends 30 minutes a week with each class. The counselor also provides more individualized or specific sessions for our students needing socialization or coping skills.

Eisenhower Elementary School offers breakfast in the classroom. Since providing breakfast in the classroom, we have seen an increase in the number of students eating breakfast. We also provide lunch for our students and 20 minutes daily of recess, as well as physical education class once a week for kindergarten and twice a week for grades one through three.



Parent and Community Involvement:

Our Parent Teacher Organization is central to our extra-curricular activities. The PTO helped to purchase 36 Chromebooks for the school. They also provided a number of educational programs for the students during the school day, including one on bullying prevention. The PTO also sponsors a monthly family activity to bring the students and their families out to enjoy a family friendly night. These include nights such as the Halloween Bash and the Mid-Year Carnival.



Facilities:

Our building houses a gymnasium/auditorium, an art lab complete with a kiln, a music room complete with sound proofing, a fully functioning library media center which includes a 36 computer laboratory, as well as a number of Chromebook carts. All the kindergarten and first grade classrooms have a bathroom in each room.
