Mission Statement

Valuing diversity and full inclusion, the mission of Cameron Ranch School is to ensure that each student becomes an informed critical thinker, strong communicator, and self-directed learner through personalized, rigorous instruction, utilizing technology, and modeling positive character traits in a safe, nurturing, respectful environment, in partnership with parents and community.

School Profile

Cameron Ranch Elementary is one of 33 elementary schools in the San Juan Unified School District. The curriculum provided is aligned to the Common Core State Standards. The school supports cultural awareness on a daily basis through its diverse literature selections and other school activities.

As a full inclusion site for children with developmental disabilities, Cameron Ranch is dedicated to developing the individual potential of all students. We believe that each student has the right to be successful academically and socially. We encourage and regularly craft lessons to align with equity and social justice standards to bring awareness to our diverse population, which is reinforced as a community responsibility. Staff and the greater school community work together to share knowledge and ideas to provide a rich learning environment for students.

We base our school behavior and discipline on the Positive Behavior Intervention and Supports (PBIS). We implement Responsive Classroom strategies and structures to provide a positive community of learners in every classroom. Students learn social skills and problem solving through Second Step curriculum lessons in our classrooms. We provide a tiered system of behavior supports including social skills groups, check-in/check-out, individual behavior charts and positive rewards. Due to the ongoing work of the entire Cameron Ranch staff, we have seen a substantial reduction in chronic absenteeism and suspensions.

The Cameron Ranch principal, teachers, and staff value diversity and excellence. Our mission is to educate and inspire each student to succeed and responsibly contribute to a radically evolving world by providing innovative, rigorous, student-focused instruction and programs in a safe, caring, and collaborative learning community.

We respond to students' needs through the analysis of data, which addresses the individual needs of each student. We use scientific, research-based programs in literacy and mathematics with the belief that every student can learn to read, write,

comprehend and compute. Within our programs we differentiate instruction employing a number of strategies to meet the varied needs of individual students.

Cameron Ranch is a data-driven school. All staff members regularly engage in powerful discussions and data analysis to meet the needs of our students. Staff gathers formative assessment information during daily instruction to target learning for each student. Ongoing data analysis provides teachers with information needed to plan focused instruction and provides internal accountability. Teachers are able to measure and monitor student progress using academic and SEL data so that instruction is precise and personalized.

We ensure that all students have access to core curriculum, all teachers are highly qualified, and interventions are checked frequently for proper placement of students. Teachers provide rigorous instruction based on Common Core State Standards.

We pay close attention to the culture and climate of our school. We provide varied opportunities for our children to learn in an environment that is safe and fosters personal and academic growth. We involve students in empathy-gathering sessions and surveys to gain insight into their perspectives and provide the same opportunities for families to share thinking, needs and desired supports. The school responds to the needs identified in the empathy gathering sessions and surveys to close the communication loop and move forward with relevant and timely action steps.

Cameron Ranch staff holds high expectations for all stakeholders. We practice the following beliefs: that every person is unique and has equal worth, that every student can and will learn, and that diversity is a valuable asset that strengthens and enriches our community. Through these multiple beliefs we have been able to start closing the achievement gap and accelerate learning.

We believe that parent involvement is the key to building a sound foundation that encourages academic and personal achievement. Caregivers are invited to Family Forum meetings as a way to engage and learn about the steps our school has designed to meet the needs of all our students. Families are encouraged to engage with the school and classroom teachers through a variety of opportunities, including, but not limited to, Family Nights, Harvest Festival, Earth Day and our Cultural Fair. Cameron Ranch strives to find ways to connect families to the learning experience thus developing an understanding of the classroom environment, how the instructional rigor is scaffolded for students throughout each day and how they can support their child's educational experience.

Professional development occurs weekly at Cameron Ranch. We provide time for grade-level collaboration and professional learning communities. We recognize the importance of ongoing teacher learning which is directly linked to instructional practices and strategies. Professional development around PBIS, Social-emotional and Mindfulness, Data Analysis, Number Talks, GLAD, iReady, Heggerty, Guided Reading, Running Records, and writing through the content area remain a priority and focus. This year, the staff is taking a deeper dive into GLAD and data driven collaborative inquiries to guide customized instruction. Staff actively working to bring real life examples and teaching points to ensure the standards are addressed, with commonly agreed upon essential standards. This work will remain in place for all Cameron Ranch students, and for the current school year, staff is engaging in professional development around targeted differentiated instruction and social-emotional learning, which includes the ongoing model of The Responsive Classroom. All of these trainings support classroom teaching strategies, school and class organization, literacy instruction, intervention, conceptual mathematical understanding and assistance, as well as home, school and community partnerships.

Cameron Ranch offers an after-school Bridges program. Bridges After-School/ASSETs Programs provide homework support, enrichment and pro-social recreation in a safe and positive environment. The Bridges After-School/ASSETs Programs currently serve over 3,000 students, grades K-12, at 32 sites. Student success is supported through the implementation of each of the four components of the program, including homework support, enrichment/disguised learning, pro-social skills/recreation, and parent support and empowerment. Strong relationships between program staff, school staff, parents and students are key. If you are interested in this program please contact the school office.

Cameron Ranch seeks to provide a high-quality instructional program where staff utilizes strategies that target learning goals, integrating relevant technology and individualized assessment data to increase student proficiency. 2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

San Juan Unified held a public hearing on September 28, 2021 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. School Facility Conditions and Planned Improvements

Cameron Ranch was modernized and a new multipurpose room was added during the 2000-2001 school year. Expanded parking was provided at the front of the school, as well as a new ramp leading down to the resurfaced blacktop playground area. Two portable classrooms were totally remodeled. Currently there is sufficient space to house the student population. There is a site custodial staff that cleans the building, along with district support for major/minor repairs. The district provides gardening and landscape services on a regular schedule. Regular fire/emergency drills are held, and badges are required for all visitors and personnel. A major landscape and irrigation project was completed during the summer of 2008 through Measure J Bond. A low voltage upgrade which includes intercoms, fire and intrusion alarms, is scheduled for completion Spring 2014. New furniture will be phased into all learning spaces over the next few years.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in October 2019 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems.

The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

Percentage of Students Meeting or Exceeding the State Standard on CAASPP

The 2019-2020 data cells with N/A values indicate that the 2019-2020 data are not available due to the COVID-19 pandemic and resulting summative test suspension. The Executive Order N-30-20 was issued which waived the assessment, accountability, and reporting requirements for the 2019-2020 school year.

The 2020-2021 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-2021 school year. Where the CAASPP assessments in ELA and/or mathematics is not the most viable option, the LEAs were allowed to administer local assessments. Therefore, the 2020-2021 data between school years for the school, district, state are not an accurate comparison. School Safety Plan

San Juan Unified School District emphasizes school safety and understands its importance in helping to achieve the academic success of its students. In accordance with the California Education Code, each school site must complete and maintain a Comprehensive School Safety Plan, to be reviewed and updated annually. The plan includes a review of safety data for the campus, safety policies, critical incident response & management information as well as emergency procedure information including those pertaining to incidents involving fire, earthquakes, intruders and other dangers. The review and update of the plan is a collaborative process involving representatives from site administration, instructional staff, custodial & classified staff, safety personnel and parent representative who together comprise a site safety team. Finalized plans are posted to site webpages for public access and presented to staff during training and development days no later than March 1 of each year. A copy of the plan is available for review in each school site office.

Safety drills are held on a regular basis and in compliance with the California Education Code to include fire drills, earthquake drills and intruder drills. Drills are coordinated and monitored with the assistance of the trained district safety personnel.

Safety is a shared responsibility. Each school site is supported by the district's Safe Schools Team. The Safe Schools Team is comprised of personnel specifically trained to support and promote school safety, provide advice to matters involving student welfare, assist in the coordination of drills and provide safety training to students and staff. Safe Schools Team members, known as Community Safety Specialists work collaboratively with site administrators and safety committee members to build and strengthen a culture of safety as well as address specific incident needs. The Safe Schools Team members are further supported through developed relationships with local law enforcement offices including the Sacramento County Sheriffs Department & Citrus Heights Police Department. San Juan Unified maintains contracts with local law enforcement for the purpose of employing uniformed law enforcement officers to further enhance school site security for special events as well as in response to critical incidents and threats. .

Professional Development

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level, and there are specific opportunities designed for our paraprofessionals to attend and be compensated. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
