## 2021-22 School Overview

The mission of Earl LeGette Elementary School, created collaboratively with staff, parents and community through site strategic planning in 2013-2014 which still applies today is as follows:

A collaborative, nurturing community, Earl LeGette TK-6 Elementary School inspires, challenges, and educates each student to excel in a dynamic world through an innovative and engaging environment that fosters creativity, develops character, ensures critical thinking, and ignites a life-long passion for learning.

### SCHOOL PROFILE

Earl LeGette Elementary is a community-based school set in a quiet neighborhood of Fair Oaks, a suburb of Sacramento, where students are able to walk, ride bicycles, or carpool as a means of getting to and from school. It is one of 41 elementary schools in the San Juan Unified School District.

Teachers at Earl LeGette use Writing Workshop and Critical Literacy as an integral framework of the English Language Arts portion of the curriculum, in alignment with Common Core State Standards. Teachers in grades K-5 use the adopted ELA curriculum- Benchmark; sixth grade uses Amplify. The math curriculum is Pearson – enVision Math for grades TK - 5; sixth grade uses Houghton Mifflin Harcourt – Go Math! During 2021-22, all teachers will continue using Swun math materials and effective math teaching strategies.

Additionally, numerous teachers have supplemented their knowledge by attending California State University, Sacramento workshops in math, aligned to the CCSS, and have worked in collaborative grade level and cross grade level groups to develop units of study. Aside from district adopted curriculum, Earl LeGette offers before-school band, choir and an after-school enrichment program (e.g. Mad Science, ceramics, school play, Early Engineers, chess, life science, Kidz Art), which are open to all students on a fee-based basis. Extended day classes are offered to students who are significantly below grade level in reading and math. Materials used for these extended day classes are researched-based and student tested.

The curriculum provided is aligned to the Common Core State Standards. The school supports cultural awareness on a daily basis through its diverse literature selections and culturally sensitive and diverse activities within and outside of the curriculum. A variety of cultural field trips are arranged by classroom/grade level to such locations as the Indian Museum in Sacramento, Sacramento Science Center, cultural art shows, and artistic presentations. The interests and needs of the Earl LeGette

students and surrounding community are reflected in programs, activities, field trips, enrichment, assemblies, and core curriculum.

### PRINCIPAL'S MESSAGE

Earl LeGette School truly provides a unique and powerful educational experience for children from the safety of our campus to the warmth of the learning environment to the rigor and breadth of the instructional programs. All aspects of our school contribute to providing students with the skills needed to be successful learners. This particular school year is one that is focusing on improving the learning of all students using the Common Core State Standards with a focus on Math.

The Common Core State Standards will prepare students to be college and career ready for the twenty-first century. This school year as we delve deeper into math, teachers in grades TK through 6 will be teaching students to use higher level thinking skills as they gain a better understanding of numeracy and math conceptual understanding. Additionally, work is being done to assist students in writing about math and problem solving steps and how to better communicate their thinking around how to solve problems.

Critical Literacy continues to focus on students thinking deeper about a story or book, asking questions about what students think of characters, story line, and plot, while looking for concepts and themes. Literal understanding is discussed, what they are thinking as they are reading, and what concepts are generated. Students then take the understanding they developed and write about it, sharing what he/she is thinking about in various sections of the story. By writing about the story, new ideas are generated.

Writer's Workshop is another ELA strategy being utilized in classrooms as teachers lead students in their writing. Teachers model how to choose a topic, how to sketch it, and how to write about it. Students are then led to independence in their writing as they apply those skills that were modeled. If students say it, they can write it. If they can write it, they can read it.

At LeGette School there are 400 Chrome Books with which students in grades 1-6 will be administered an online assessment two times a year (3 times for 2nd grade)---iReady. These will allow teachers to understand what students know and what they still need to learn while giving students the practice in using the Chromebooks for the online assessments. Students will be taking state assessments in a similar manner through Smarter Balanced Assessments. Sixty-eight out of the 280 are used primarily by 6th grade for their ELA program- Amplify.

Parent support and involvement are our greatest assets and continue to be great contributors to the educational success of our students. This support is given, recognized, and appreciated in many different ways. Some parents help plan the programs and policies, while others serve as classroom volunteers, plan family activities or work as art docents. Parents also support student success by providing space, time and encouragement for daily homework and by sending a clear message that education and regular school attendance are important to the family.

The safety of our students is the school's first priority and the behavior policy is strictly enforced. We emphasize cooperation as well as respectful and responsible behavior which leads to the safety of all of our LeGette family members. All adults visiting

the campus are required to check in through the school office. The atmosphere of LeGette School allows our students to feel comfortable and secure. Additionally, monthly fire drills, bi-monthly lock down drills, and quarterly earthquake drills are practiced to ensure students are prepared in the case of a real emergency.

## 2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

## School Facility Conditions and Planned Improvements

LeGette Elementary School, constructed in 1957, was modernized during the 1997-1998 school year. The scope included roof/repair or replacement, interior, and exterior painting, window system replacement, energy efficient lighting was added, new doors with handicapped accessible hardware, restroom restoration, electrical infrastructure upgrade to provide for internet, cable, telephone, new fire, intrusion, and intercom system, throughout the school. Window air-conditioning units were added to the classrooms. Currently, there is sufficient space to house the student population. Site custodial staff clean the buildings, along with district support for major/minor repairs. The district provides gardening and landscape services on a regular schedule. Regular fire/emergency drills are held, and badges are required for all visitors and personnel. In 2006, under the Measure J Bond, a new heating and air conditioning system was installed along with new gas lines and an Energy Management System. Field repair, driveway resurfacing, and irrigation system retrofit continue to be a concern. In the summer of 2008, the parking lot was redesigned and overlaid including ADA and safe route work through the Measure J Bond.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The Board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in August 2020 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually the district budgets \$2 million dollars for deferred maintenance activities.

## B. Pupil Outcomes

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

## Percentage of Students Meeting or Exceeding the State Standard on CAASPP

The 2019-2020 data cells with N/A values indicate that the 2019-2020 data are not available due to the COVID-19 pandemic and resulting summative test suspension. The Executive Order N-30-20 was issued which waived the assessment, accountability, and reporting requirements for the 2019-2020 school year.

The 2020-2021 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-2021 school year. Where the CAASPP assessments in ELA and/or mathematics is not the most viable option, the LEAs were allowed to administer local assessments. ## 2021-22 School Safety Plan

### School Safety Plan

San Juan Unified School District emphasizes school safety and understands its importance in helping to achieve the academic success of its students. In accordance with the California Education Code, each school site must complete and maintain a Comprehensive School Safety Plan, to be reviewed and updated annually. The plan includes a review of safety data for the campus, safety policies, critical incident response & management information as well as emergency procedure information including those pertaining to incidents involving fire, earthquakes, intruders and other dangers. The review and update of the plan is a collaborative process involving representatives from site administration, instructional staff, custodial & classified staff, safety personnel and parent representative who together comprise a site safety team. Finalized plans are posted to site webpages for public access and presented to staff during training and development days no later than March 1 of each year. A copy of the plan is available for review in each school site office.

Safety drills are held on a regular basis and in compliance with the California Education Code to include fire drills, earthquake drills and intruder drills. Drills are coordinated and monitored with the assistance of the trained district safety personnel.

Safety is a shared responsibility. Each school site is supported by the district's Safe Schools Team. The Safe Schools Team is comprised of personnel specifically trained to support and promote school safety, provide advice to matters involving student welfare, assist in the coordination of drills and provide safety training to students and staff. Safe Schools Team members, known as Community Safety Specialists work collaboratively with site administrators and safety committee members to build and strengthen a culture of safety as well as address specific incident needs. The Safe Schools Team members are further supported through developed relationships with local law enforcement offices including the Sacramento County Sheriffs Department & Citrus Heights Police Department. San Juan Unified maintains contracts with local law enforcement for the purpose of employing uniformed law enforcement officers to further enhance school site security for special events as well as in response to critical incidents and threats. .

## Professional Development

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level, and there are specific opportunities designed for our paraprofessionals to attend and be compensated. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
