PRINCIPAL'S MESSAGE

Lichen P-8 School serves preschool through eighth grade students in the Citrus Heights community. We partner with the Bridges After-School office to provide an after-school program that supports positive social development and assistance with homework at no cost to our families.

Lichen partners with the Sunrise Parks and Recreation District to provide organized sports programs after school for boys and girls. We work closely with the Citrus Heights Police Department and Citrus Heights City Council. We partner with many organizations within the Citrus Heights community to support our students and parents academically, socially, and emotionally.

All Lichen students receive core instruction in their classrooms daily. Lichen also offers Intervention for students grades 1-4 from a primary interventionist, and grades 5-8 with our middle years interventionist. Sixth, seventh, and eighth grade students have a period of "Acceleration" during their elective period. Students are able to receive additional supports in ELD, RSP, or core curriculum during this time. In addition, many students receive extensions and other academic opportunities during 'Acceleration' to further their development. After-school tutoring is available in grades 4-5.

Our goal is to develop confident learners who are ready with the skills they need for high school and beyond.

MISSION STATEMENT

In partnership with our diverse community, the mission of Lichen P-8, a collaborative neighborhood school of excellence, is to inspire and engage all students to succeed in an ever-changing world through positive character trait development and innovative student-centered academic rigor embedded with technology and enriched by the arts.

SCHOOL PROFILE

Lichen K-8 school is one of eight P-8 schools in the San Juan Unified School District. The school supports cultural awareness on a daily basis through its diverse literature selections and other school activities. The curriculum provided is aligned to the California Common Core State Standards.

SJUSD K-8 Philosophy: The P-8 schools in the San Juan Unified School District will provide an alternative to the middle school environment for parents and students. The school staff and the community work collaboratively to allocate the resources and

plan programs to the advantage of all students. All students receive instruction in their grade level academic standards as well as experience enriching activities that take them beyond the academic core. There are high expectations academically, and student responsibility is stressed. In a stable community setting, teachers follow the development of children from kindergarten through the beginning years of adolescence in the seventh and eighth grades. Parents are an integral aspect of the school setting providing assistance in the classroom and with school-wide programs. The entire staff strives to give middle school students the opportunities to develop leadership roles in a smaller, more familiar setting. Younger students benefit in their academic and social development from these positive role models. The school also provides opportunities for social development by providing activities that are age appropriate.

2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

San Juan Unified held a public hearing on September 28, 2021 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. School Facility Conditions and Planned Improvements

Lichen K-8 School, constructed in 1962, was modernized during the 1999-2000 school year. A new wing was added to the school in 2003 which replaced 8 portable rooms. In 2009 a new turn around area for student drop-off and pick-up and resurfacing of our current parking lot was completed. Security cameras were added to the outside of the campus and all rooms include internet access. The school was painted in 2009 through Deferred Maintenance funding. Currently, there are enough classrooms to house the student population. Site custodial staff keep our buildings clean and safe. The district provides gardening and landscape maintenance as well as personnel to keep electrical plumbing, heating and air conditioning systems maintained and functioning. Regular fire/emergency drills are held, and badges are required for all visitors and personnel. All restrooms site-wide were reconfigured and renovated in Fall 2013 using Measure J funds. This included all plumbing, fixtures, partitions, floors, walls, path of travel and upgrades to meet ADA requirements. Lichen will have sufficient space to house the student population. There is a site custodial staff that cleans the building, along with district support for major/minor repairs. The district provides gardening and landscape services on a regular schedule.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in August 2020 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

School Safety Plan

San Juan Unified School District emphasizes school safety and understands its importance in helping to achieve the academic success of its students. In accordance with the California Education Code, each school site must complete and maintain a Comprehensive School Safety Plan, to be reviewed and updated annually. The plan includes a review of safety data for the campus, safety policies, critical incident response & management information as well as emergency procedure information including those pertaining to incidents involving fire, earthquakes, intruders and other dangers. The review and update of the plan is a collaborative process involving representatives from site administration, instructional staff, custodial & classified staff, safety personnel and parent representative who together comprise a site safety team. Finalized plans are posted to site webpages for public access and presented to staff during training and development days no later than March 1 of each year. A copy of the plan is available for review in each school site office.

Safety drills are held on a regular basis and in compliance with the California Education Code to include fire drills, earthquake drills and intruder drills. Drills are coordinated and monitored with the assistance of the trained district safety personnel.

Safety is a shared responsibility. Each school site is supported by the district's Safe Schools Team. The Safe Schools Team is comprised of personnel specifically trained to support and promote school safety, provide advice to matters involving student welfare, assist in the coordination of drills and provide safety training to students and staff. Safe Schools Team members, known as Community Safety Specialists work collaboratively with site administrators and safety committee members to build and strengthen a culture of safety as well as address specific incident needs. The Safe Schools Team members are further supported through developed relationships with local law enforcement offices including the Sacramento County Sheriffs Department & Citrus Heights Police Department. San Juan Unified maintains contracts with local law enforcement for the purpose of employing uniformed law enforcement officers to further enhance school site security for special events as well as in response to critical incidents and threats. .

Professional Development

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level, and there are specific opportunities designed for our paraprofessionals to attend and be compensated. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
