School Profile:

Twin Lakes Elementary School is a TK-6 school with a focus on developing the whole child through academics, fine arts, and fitness in order for children to reach their full potential. We believe that children need the opportunity to express themselves in many ways: through writing, movement, music, as well as visual and performing arts. The staff at Twin Lakes is committed to teaching students the skills they will need to be successful in the twenty-first century. These "survival skills" include: critical thinking & problem solving, collaboration & leading by influence, agility & adaptability, initiative & entrepreneurialism, effective oral & written communication, accessing & analyzing information and curiosity & imagination. In order for students to learn these skills, they need exposure and opportunities beyond the basic academic skills. We provide these opportunities through comprehensive balanced literacy in language arts and across the curriculum and engage students in enrichment classes during, before, and after school hours. By partnering and working collaboratively with parents and community members, we can provide the best, comprehensive educational experience for all children.

School Programs:

Technology:

We have one computer lab at Twin Lakes which is adjacent to our library. The computer lab provides students the opportunity to access information in multiple ways. Teachers bring their classes during scheduled times and the students can complete research projects in many academic areas by using the library and internet resources. Additionally, we have 14 COW

(computer on wheels) carts, one in each 2nd - 6th grade class, which allow students to access technology and online academic programs. All students are encouraged to check-out books from the library and to read at every opportunity.

Comprehensive, Balanced Literacy:

Comprehensive literacy is the focus of our school. Our approach to accomplish high-quality personalized instruction is through the gradual release of responsibility model. Through the use of interactive read-alouds, shared reading/writing, guided reading and independent reading/writing, teachers are able to assist students in their learning in a personalized way. Students are regularly assessed by teachers so that there is a clear understanding of what students know and are able to do. These skills are essential for success in college and career.

Twin Lakes also offers online programs to support students' independent reading growth. Many classes utilize the Accelerated Reader program to motivate students to read books at their independent reading level, and we also offer a school-wide license to iReady.

Art, Music, Physical Education:

The staff at Twin Lakes believe that art, music, and physical education are just as important in a child's development as reading, writing, and math. All students in grades kindergarten through sixth grade participate in specialized programs taught by highly qualified teachers. Student's art work is displayed in the school and in the community. All children are taught appropriate developmental physical skills and the importance of nutrition. All children are taught to sing and express themselves through music and take part in class or in grade level performances. Many staff members have been trained in the Education Through Music Program which was taught by our music teacher and other professionals.

2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

San Juan Unified held a public hearing on September 28, 2021 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. School Facility Conditions and Planned Improvements

Twin Lakes Elementary School is evaluated for ongoing maintenance needs on a yearly assessment. This evaluation includes roof repair or replacement, exterior painting, energy-efficient lighting, heating and cooling system condition, doors with handicapped accessible hardware, restroom restoration, electrical infrastructure ability to provide for internet, cable, telephone, new fire, intrusion, and intercom systems. Currently, there is sufficient space to house the student population. There is a site custodial staff that cleans the building along with district support for major/minor repairs. The district provides gardening and landscape services on a regular schedule. Regular fire/emergency drills are held, and badges are required for all visitors and personnel. Field repair, and irrigation system retrofit continues to be a concern. In 2005, under Measure J Bond a new gas service was installed to support future heating and air conditioning upgrades. In addition, a low voltage upgrade using Measure J funds was completed in Spring 2014; this included intercoms, fire and intrusion alarms.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in September 2020 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually the district budgets two million dollars for deferred maintenance activities.

School Safety Plan

San Juan Unified School District emphasizes school safety and understands its importance in helping to achieve the academic success of its students. In accordance with the California Education Code, each school site must complete and maintain a Comprehensive School Safety Plan, to be reviewed and updated annually. The plan includes a review of safety data for the campus, safety policies, critical incident response & management information as well as emergency procedure information including those pertaining to incidents involving fire, earthquakes, intruders and other dangers. The review and update of the plan is a collaborative process involving representatives from site administration, instructional staff, custodial & classified staff, safety personnel and parent representative who together comprise a site safety team. Finalized plans are posted to site webpages for public access and presented to staff during training and development days no later than March 1 of each year. A copy of the plan is available for review in each school site office.

Safety drills are held on a regular basis and in compliance with the California Education Code to include fire drills, earthquake drills and intruder drills. Drills are coordinated and monitored with the assistance of the trained district safety personnel.

Safety is a shared responsibility. Each school site is supported by the district's Safe Schools Team. The Safe Schools Team is comprised of personnel specifically trained to support and promote school safety, provide advice to matters involving student welfare, assist in the coordination of drills and provide safety training to students and staff. Safe Schools Team members, known as Community Safety Specialists work collaboratively with site administrators and safety committee members to build and strengthen a culture of safety as well as address specific incident needs. The Safe Schools Team members are further supported through developed relationships with local law enforcement offices including the Sacramento County Sheriffs Department & Citrus Heights Police Department. San Juan Unified maintains contracts with local law enforcement for the purpose of employing uniformed law enforcement officers to further enhance school site security for special events as well as in response to critical incidents and threats. .

Professional Development

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level, and there are specific opportunities designed for our paraprofessionals to attend and be compensated. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
