

SIDEBAR AGREEMENT
MIDDLETOWN TOWNSHIP BOARD OF EDUCATION (BOARD)
And
MIDDLETOWN TOWNSHIP EDUCATION ASSOCIATION (ASSOCIATION)

This Sidebar Agreement is made this 17th day of August 2022, between the Board and the Association.

WHEREAS, the Board and the Association are parties to a Collective Negotiations Agreement (“CNA”) for the period of July 1, 2017 through June 30, 2021; and

WHEREAS, Schedule D2 of the CBA sets forth certain stipends for extracurricular activities and organizer/advisor position; and

WHEREAS, effective for the 2022-2023 school year, the parties desire to adjust the stipend position of one (1) district-wide Head Nurse; and

WHEREAS, responsibilities for the district-wide Head Nurse position include, but are not limited to the following:

- One individual will hold the position of Head Nurse;
- Work under collaborative agreement with the school physician to address medical concerns and health issues that arise in the school district during school hours;
- Act as a liaison for the school district with state and local health agencies;
- Introduce preventative and wellness education projects; and
- Consult on case medical and health management concerns.

NOW, THEREFORE, IT IS AGREED, as follows:

1. Effective for the 2022-2023 school year, one (1) stipend position for Head Nurse shall be adjusted. If the Head Nurse responsibilities are shared, the stipend will be pro-rated.

2. The stipend amounts for the Head Nurse position for 2022-23, which are then subject to negotiations for any successor CNA, are as follows:

3. This Agreement contains the entire Agreement and understanding between the parties.

4. If a specific clause of this Agreement is determined to be illegal or in violation of any Federal or State law, the remainder of the Agreement shall not be affected by such a ruling and shall remain in full force and effect.

5. The parties shall be bound by the terms and conditions of this Agreement and agree that the terms of this Sidebar are subject to negotiations for any successor CNA.

6. The parties have entered into this Agreement freely and voluntarily. The parties acknowledge that the foregoing constitutes their entire agreement regarding the terms and conditions of employment.


