PUBLIC LAW 81-874 (Federal Impact Aid)

Procedure

Timeline

1. A federal card survey will be made during the first Semester of each school year for all students attending schools in Douglas County. Sept./Oct.
 2. P. L. 81-874 funds are part of the total general fund operating budget for the Douglas County School District. Public hearings on the proposed annual budget, in compliance with Nevada Revised Statutes, are conducted at which time all interested parties are offered an opportunity to make comments and recommendations concerning educational programs of the Douglas County School District. April/May
 3. An agenda for each regular meeting of the School Board held on the second Tuesday of each calendar month will be mailed to the Washoe Reservation Tribal Office for posting three days prior to the meeting pursuant to the Open Meeting Law of Nevada Revised Statutes. Second Tuesday of each month
 4. An agenda for each regular meeting of the School Board held on the second Tuesday of each calendar month will be mailed to the chairperson of the Washoe Tribe's Education Committee three days prior to the meeting. Within 72 hours of Board Meetings
- Every Native American student will receive a written summary of the deliberations and actions of each meeting of the Douglas County School District Board of Trustees.
- The Douglas County School District will send summaries of materials such as P.L. 81-874 applications, evaluations of educational programs, and educational program plans to all tribal officials and parents of Native American students with notification that a more detailed report may be obtained on request. As necessary

| 5. Native American parents and tribal officials will be surveyed regarding the equality of Native American children's participation in the education program. The School Board will review the survey results and, if necessary, modify the educational program to allow Native American children to participate on an equal basis. | Spring Survey |
| 6. Douglas County School District officials and the Washoe Tribe's Education Committee will meet annually to review the following:

a. Annual report on evaluation of achievement tests.

b. Effective dissemination of information to Native American parents.

c. Program plans and modifications.

d. Attendance and participation of Native American students in school programs.

e. P. L. 81-874 grant application.

f. Written survey of Native American parents regarding their opinion of their child's equality of participation in the educational program.

| 7. Representatives of the Douglas County School District, the Washoe Tribe's Education Committee, and parents of Native American children, acting as an ad hoc committee, will examine input from tribal officials and Native American parents for consideration of program revisions by answering the following questions.

a. Is the comment general or specific to one school, person, or situation?

b. Does the comment require modification in the District's curriculum? | As Needed |

 - e. Will inclusion require new funds and, of so, what other program(s) will be impacted?
8. Douglas County School District officials will seek out and encourage participation in school programs by members of the Washoe Tribe's Education Committee and other Native American parents as volunteers, presenters, etc. Ongoing
9. Douglas County School District officials and the Washoe Tribe's Education Committee will hold meetings or conferences as requested by either party. Ongoing
