## **1. CALL TO ORDER**

## **2. WELCOME AND INTRODUCTIONS OF MEMBERS AND GUESTS**

## **4. EMPLOYEE WELLNESS PROGRAM UPDATE**

Minutes: Noella Whavers provided an update on the Safety Resource Persons and Safety/Wellness Campaigns. She discussed the Top Safest Schools Awards from previous years for schools that had no accidents that involved a doctor's care. Ms. Whavers discussed the School Employee Recognition Campaign and examples of various rewards including plaques and funds for safety materials. Various wellness challenges were discussed such as Take Heart, Add and Subtract, Choose to Lose and Drink More Water campaigns.

## **5. CHILD NUTRITION UPDATE**

Ms. Marcum discussed department highlights including the recent hire of a new director, employee recognition, meal pricing changes, and other items. Updates included 1.1 million meals served, an 83% free/reduced lunch student population, after school snack programs, and other items. Items that are coming in the near future include the Texas Department of Agriculture Farm Fresh Program and Administrative Review and menu enhancements with new entree options.

## **6. CURRICULUM FOR HUMAN SEXUALITY INSTRUCTION**

Ms. Brown reviewed the adoption process for the Human Sexuality Curriculum. The Board will vote on the recommendations made by SHAC in May. Parents will have to opt in if they want their students to participate in human sexuality instruction. The curriculum adopted was the Goodheart-Willcox Curriculum. Only students whose parents opt in will receive the companion text in health class for middle and high school students.
