Fine Arts Seal Criteria

As part of Ohio's graduation guidelines students may earn a Fine Arts Seal. In order to earn a Fine Arts Seal at Valley View High School the student must complete one of the requirements below, acquire the appropriate signatures and turn in this form and the verification forms to your counselor before May 1st of your senior year.

Requirement 1:

1. You must earn 2.0 CREDITS in Fine Arts courses (This could mean 4 courses)
 - a. Visual Art (Art fundamentals (.5), Studio Art(.5), etc)
 - b. Digital Art (Photo courses (.5), etc)
 - c. Drama courses (.5) (Includes Mass Media(.5) and Video Production (.5))
 - d. Choir (1.0), Band (1.0), Music Technology(.5)
 - e. CCP courses in the Fine Arts - see your counselor for questions

Requirement 2

You must participate in 2 approved fine arts related extracurricular activities during your high school career. The teacher/advisor's signature is required to document your participation. You must complete/perform/be in good standing to verify participation.

Approved Activities: Fall Dinner Theater and a Show, Spring musical, Marching Band, Drill Team, National Art Honor Society, Teacher approved Art Shows such as Scholastic Art, Miamisburg Student Exhibit, Governor's and Congressional, OAEA Emerging Artist, Choir/Band Contest, Dance Team, etc.

Any activity not listed must be pre-approved by a Valley View Fine Art Educator for that area of study
