## 1. Meeting Called to Order by Chair

Chair Spence called the meeting to order at 6:07 p.m.

#### 2. Pledge of Allegiance and Moment of Silence

Pam Parker called the roll and recorded members in attendance for the meeting.

# 5. Approval of Agenda

# 6. Recognitions

Mrs. Rachael Haines introduced Mary Hazel Small from the North Carolina Association of School Business Officials who recognized Susan Morris for her completion of the NCASBO Manager's Academy. Dr. Parker thanked Susan for her outstanding work.

Dr. Parker stated there is a lot of talent in our school system and recognized several young people who had the courage to attend the Dr. Martin Luther King rally on Monday. Dr. Parker introduced Noah Turner and Tyler Spellman as they each played a selection they performed at the rally on Monday. Dr. Parker also introduced several students who spoke at the rally on Monday: Josiah Bennett, Steven Clark, Shaun Hoffler, Jarret Dobie, Seith Boyd, Jakael Brooks, and Gabrielle Rivers introduced the guest speaker. Dr. Parker thanked all those that participated.

Mrs. Sheila Hughes, Director of CTE introduced Joel Overman, FFA student at Northeastern High School. Mrs. Hughes stated Joel has worked hard to complete his supervised agricultural experience or what we call FAE through his produce stand where he grows local vegetables and sells them to the public. Joel was recognized by the North Carolina FFA Association during their SAE Spotlight for January 2023 for his outstanding project and progress over the years.

Mr. Nick Stanley, Pasquotank County High School Band Director, stated on January 14, he has several students audition for the North Carolina BandMasters Eastern All District Band. Mr. Stanley stated this band is made up of students from across the eastern part of North Carolina. Mr. Stanley stated he had two students in the honors band and they each prepared a challenging solo, worked on their scales and sight read a piece of music before a panel of judges. Mr. Stanley stated Antoinio Garica-Diaz and Emily Stokely will perform on February 4th at East Carolina University, They will also audition for the All-State band on Saturday, March 4th in Winston-Salem.

This will be an opportunity for any ECPPS employee that would like to expand their leadership and are welcome to apply for this program. The focus for this program is to invite teachers or school leaders that are interested in school leadership. Dr. Parker recognized the board members for Board appreciation month.

Holley recognized the swim team and all their hard work. Holley also congratulated Emily Stokely and Antonio Gracia Diaz for making the Eastern Region All District Band. Holley shared upcoming events: DECA State Competition on February 22nd and the 25th, and NC Check-Ins/Benchmark Assessments will take place between February 27- March 1st.

Grace Wooten, representative from Northeastern High School recognized the graduation cohort that was hosted at NHS on January 12th for juniors and seniors. Grace stated this event was to help students figure out how to prepare for college and to be college ready. Grace stated she sent out a google form to ask questions about being back in school. Grace shared that Gabby Johnson, member of Northeastern's swim team qualified for the women's 200 lm, 50 and 100 freestyle. Grace also stated Joel and Haven Overman also were very close to qualifying, and will be trying again on Wednesday.

Dr. Parker said he is very excited about the work in ECPPS.
