MISSION

Inspired by St. John Baptist de La Salle, La Salle Catholic College Preparatory develops students of faith, service, and scholarship by providing a transformative education allowing students to realize their maximum potential and use their gifts to serve Christ and humankind.

La Salle optimizes financial and academic accessibility for students, especially the underserved, who desire a rigorous and relevant education preparing them for college and life.

The La Salle Prep community inspires students to find their voice as global citizens, to put their faith into action, and to lead exceptional lives of integrity, honoring the God-given dignity of all.

HISTORY

Since 1966, La Salle has been providing a quality, Catholic, college-preparatory education to students of the Portland/Vancouver metropolitan area. La Salle serves a socio-economically diverse student population; about 30% of our population identifies as culturally diverse and 60% is Catholic.

La Salle is sponsored by the Brothers of the Christian Schools and is one of 1,600 Lasallian educational institutions located in over 80 countries worldwide. The Christian Brothers were founded in 1682 by St. John Baptist de La Salle, an aristocrat in Rheims, France. De La Salle was also a Roman Catholic priest and canon lawyer, who used the whole of his inheritance to further the education of poor children, the children of 17th century France's artisan class. Named Patron Saint of Teachers by the Catholic Church in 1953, many characteristics of modern education that we take for granted, such as lessons in common (instruction previously had occurred one-on-one, with tutors), a fixed class schedule, fixed arrival and departure times, education in the vernacular (it had previously occurred only in Latin), first appeared in De La Salle's schools.

However, what made De La Salle a pioneer and an educational innovator were his tenets that teaching is rooted in an authentic love of students and that a truly effective teacher-student relationship must be based on practical affection and mutual respect. This core philosophy remains the foundation of De La Salle's many contributions to education and is a unifying characteristic of Lasallian schools worldwide.

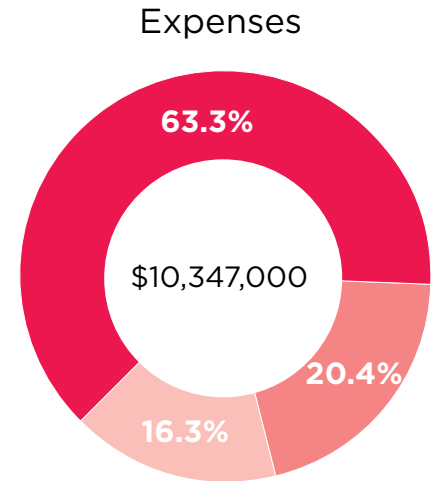
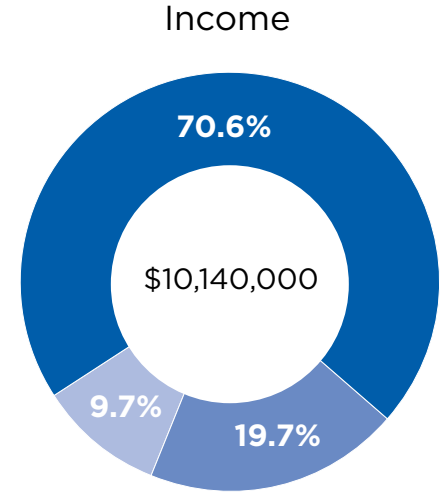

A commitment to providing access to education is at the heart of the Lasallian mission. For more than 300 years, Lasallians worldwide have pledged to serve the needs of those who need it most through education and opportunity. Teachers and staff at La Salle Prep work diligently to provide qualified students access to an excellent college preparatory education, regardless of their ability to pay. Through fundraising activities and in partnership with generous foundations and benefactors, La Salle Prep provided need-based tuition assistance to 62% of the student body for a total of over \$2.79 million in 2021-22.

CHANGING TODAY AND TOMORROW

Incorporated in 1996, the La Salle Educational Foundation exists exclusively for the benefit of La Salle Catholic College Preparatory. Its purpose is to ensure the financial sustainability and permanence of the mission to provide a Catholic college-preparatory education to the young, especially the poor.

A gift to the La Salle Educational Foundation ensures we can continue to aid those of limited financial means, provide a faith-based educational option to interested families and facilitate and foster the growth of our students' God-given gifts for years to come. Rather than be used for immediate needs, gifts to the Foundation are professionally invested. Earnings on these investments provide a permanent, renewable source of funding. The base of the Foundation continues to grow year after year, with distributions coming from the accrued interest of the funds rather than the corpus. The corpus of the fund will never be depleted.

The total net asset balance in the La Salle Foundation as of December 31, 2022, was \$6.9 million. The annual distribution from the Foundation for the 2021-22 school year was \$264,000 with a deposit and growth rate* of 76% in 5 years. There are 43 active named funds and 4 developing named funds in the Foundation which provided scholarship assistance to 44 students. The La Salle Legacy Society — a group of benefactors who wish to leave a legacy for future generations of La Salle students through provisions for La Salle in their estate plans — has grown to 48 members.
