- What is "Title I-A"?
 - Title I-A is United States Government's largest education assistance program for schools.
 - Funds are used to provide programs to help children who are struggling in reading and math.
 - Extra help (in addition to what they learn during math and reading time in the classroom)
 - Funding provided under ESEA



Design of our Title Program

- Schoolwide all students may be served as a part of Reading Small Groups
- Targeted instruction for students identified based on performance on assessments.

- Regularly evaluate student progress and offer appropriate instructional interventions to students needing additional assistance.

- Encourage your child to show positive school behavior.
- Continue to review your child's homework
- Encourage limited electronic use and encourage positive use of your child's extracurricular time.
- Volunteer in school (as regulations allow)
- Attend parent-teacher conferences and participate, when appropriate, in decisions relating to the education of your child.
