The Power of Time Don't Let Time Pass You By

It can be difficult to make up for lost time when you're investing, but a small systematic contribution toward your retirement each payday can significantly add to your retirement funds. By contributing with pre-tax dollars you maximize the benefit to your 403(b)/457(b) — reducing your current taxable income — plus the entire investment is tax-deferred. The chart below shows the potential benefit of contributions over time with a 6% annual rate of return.
