This contract covers daycare services to be provided for the **2014-2015** school year. Before School care shall begin on <u>August 20, 2014</u> and shall end on <u>June 2, 2015</u>. Below is a summary of charges that will be posted to your account monthly. Also, listed are additional fees that will be charged when applicable. Please read all the policies carefully before signing this contract.

- 1. **Registration Fee- \$100.00** payment for the first and last month of the school year tuition will be due at the time of this signed contract.
- 2. Tuition- A charge of \$100.00 will be posted to your account on the FIRST of each month. TUITION IS DUE EACH MONTH BY THE LAST BUSINESS DAY OF THE MONTH PRIOR TO SERVICES BEING PROVIDED. - 4. **Hours of Services Before School Extended Care** hours are 6:30 a.m.-to until school starts daily.
- 5. **Early Withdrawal**-If the need arises for you to withdraw your child(ren) from the program, *you must submit a TWO WEEK WRITTEN NOTICE to the supervisor of the Merrillville Schools Extended Daycare*. A tuition charge of \$77.50 will be applied to your account if no notification is received.
- 6. **Handbook** You will receive a handbook when the school year begins. *It is* your responsibility to read over and review with your child our policies and rules.
- 7. Your tuition covers services for the entire month. There are no pro-rated fees for days that the service is not used by your child.
