

**QUALIFICATIONS FOR BARTLETT INDEPENDENT SCHOOL DISTRICT  
SCHOOL BOARD APPLICANT

**THE FOLLOWING ELIGIBILITY REQUIREMENTS ARE OUTLINED FOR THE BENEFIT OF THE CANDIDATE, THE ELIGIBILITY REQUIREMENTS MAY CHANGE FROM TIME TO TIME, AND IT IS THE CANDIDATE'S RESPONSIBILITY TO ENSURE THAT HE/SHE HAS MET ALL OF THE APPLICABLE REQUIREMENTS EXISTING AT THE TIME THE CANDIDATE FILES HIS/HER APPLICATION.**

**FROM THE ELIGIBILITY SECTION 141.001 of the TEXAS ELECTION CODE:**

- 1) No person shall be eligible to be a candidate for or to be elected to any public office unless he or she:
  - a) Is a citizen of the United States;
  - b) Will be 18 years of age or older on the commencement of the term to be filled by the election;
  - c) Is not mentally incompetent as determined by a final judgment of a Court;
  - d) Has not been finally convicted of a felony for which candidate has not been pardoned or otherwise released from the resulting disabilities;
  - e) Has been a continuous resident of the State for 12 months and has resided within Bartlett Independent School District for six (6) months prior to the filing deadline (**February 18, 2022**);
  - f) Agrees to serve without compensation;
  - g) Satisfies any other eligibility requirements prescribed by law for the office;
  
- 2) Candidate must be registered to vote in the territory from which the office is elected.
  
- 3) Candidate must file his/her completed application to be placed on the ballot with the Bartlett ISD Administration Office, 404 North Robinson, P.O. Box 170, Bartlett, TX 76511 no earlier than 8:00 a.m. Wednesday, **January 19, 2022**, and no later than 5:00 p.m. Friday, **February 18, 2022**.  
**Applications must be received no later than 5:00 p.m. February 18, 2022. (If application is mailed/emailed, it must be received in the office no later than 5:00 p.m. February 18, 2022.)**
  
- 4) ***Form CTA (Campaign Treasurer Appointment) must be filed with the Bartlett ISD Administration Office, 404 North Robinson, P.O. Box 170, Bartlett, TX 76511, on or before the date candidate files his/her application to be placed on the ballot.***
