## **Resolution to Reinstate the Ohio Association of School Business Officials 457 Deferred Compensation Plan**

WHEREAS, Clark-Shawnee Local Schools has previously adopted the Ohio Association of School Business Officials ("OASBO") 457 Deferred Compensation Plan (the "Plan"), a retirement plan (the "plan") under Section 457(b) of the Internal Revenue Code of 1986, as amended (the "Code");

WHEREAS, OASBO last provided its member school districts with an amended and reinstated Plan, effective as of April 1, 2017, for adoption as the Plan;

WHEREAS, the Setting Every Community Up for Retirement Enhancement Act and the Coronavirus Aid, Relief, and Economic Security Act of 2020 would, in relevant part, require the Clark-Shawnee Local Schools to amend the Plan to ensure compliance with Section 457(b) of the Code and the regulations thereunder; and

WHEREAS, as a Participating Employer under the Plan, Clark-Shawnee Local Schools wishes to also permit Roth 457(b) contributions, as permitted under the Plan; and

WHEREAS, Clark-Shawnee Local Schools desires to amend and reinstate the Plan to incorporate the following changes:

1. Section 1.5 – Added a definition of "CARES Act".
2. Section 1.12 – Added a definition of "Eligible Designated Beneficiary".
3. Section 3.5 – Amended to permit repayments to the Plan of "CARES Act" distributions received by a Participant in 2020.
4. Section 4.1 – Amended to permit an active employee to make withdrawals at age 59-1/2.
5. Section 4.1 - Also amended to permit an employee under age 59-1/2 to make a CARES Act withdrawal in 2020 of up to \$100,000.
6. Section 4.3 – Amended to address the SECURE Act's change that has the minimum distribution rules apply at age 72, instead of age 70½. This includes authority for VOYA and Equitable to independently address transitional rule matters under their Provider Contracts with their own customers.

7. Section 4.4 - Amended to address the SECURE Act's modification of the minimum distribution rules that apply after the death of a Participant.
8. Exhibit A – Loan provisions – Loan provisions are modified to permit a Participant to take a loan of up to \$100,000 on or before September 23, 2020, as was allowed by the CARES Act.

NOW THEREFORE BE IT RESOLVED THAT: Effective March 21, 2023, the Board of Clark-Shawnee Local Schools (the "Board") authorizes Clark-Shawnee Local Schools to adopt the Plan as amended and reinstated for such federal legislation.

BE IT FURTHER RESOLVED THAT: the Board authorizes the school business official of Clark-Shawnee Local Schools to execute the Plan.

**Resolution Waiving Competitive Bidding and Authorizing Contract with Leonard Mechanical for HVAC System Replacement and Installation at the Student Athletic Center Based Upon an Urgent Necessity/Public Exigency**

Mr. Brian Kuhn, Superintendent, recommends that the Board waive competitive bidding based upon urgent necessity and public exigency exceptions and authorize a contract with Leonard Mechanical Services Inc. ("Leonard Mechanical") for the Student Athletic Center HVAC Upgrade Project ("the Project"). The Superintendent requests authority for the Superintendent and Treasurer to negotiate and enter into an agreement with Leonard Mechanical for the work on the Project.

**Rationale:**

1. The Board has identified a need to update the existing facilities used to cool the weight room, gymnasium and locker rooms and to install heating system components in the training room at the Student Athletic Center.
2. The work for the Project needs to be completed prior to the 2023/2024 school year and within the District's budget so as not to negatively impact the District's educational programs. Bidding the work will delay the Project completion, could result in higher costs, and will not guarantee that lower bids will be received for the work, especially given long lead times for HVAC components attributed to continued supply chain disruptions related to COVID-19 and continuing global disruptions. Accordingly, this situation presents an urgent necessity under R.C. § 3313.46 and public exigency under 2 C.F.R. § 200.320(c)(3).
3. Leonard Mechanical is an experienced contractor for HVAC projects and has provided a proposal for the Project in the amount of \$195,500. Based on experience in procurement, the Superintendent and Treasurer believe Leonard Mechanical's proposal to be reasonable and of an appropriately competitive nature.
4. The Superintendent recommends Leonard Mechanical as being the contractor in the best interest of the District and requests authority for the Superintendent and Treasurer to negotiate and execute a contract and any supporting documents with Leonard Mechanical in an amount not to exceed \$195,500 ("Contract Sum").
5. The Superintendent also requests authority to enter into change orders on behalf of the Board in a total amount not to exceed 10% of the Contract Sum with Leonard Mechanical; change orders in excess of that amount will be brought to the Board for its approval.

**The Board of Education resolves as follows:**

1. Based upon the information provided and exercising the authority given in R.C. § 3313.46, the Board declares an urgent necessity and declares a public exigency under 2 C.F.R. § 200.320(c)(3) relating to the Project.
2. The Board approves the selection of Leonard Mechanical to provide the work and authorizes the Superintendent and Treasurer to work with legal counsel to negotiate and execute a contract and any supporting documents with Leonard Mechanical in an amount not to exceed \$195,500.00, and any other documents necessary to effectuate the intent of this resolution.
3. The Board further authorizes the Superintendent and Treasurer to sign change orders related to the Project in a total amount not to exceed 10% of the Contract

Sum with Leonard Mechanical; should a change order exceed this amount individually or as the aggregate of change orders for the work, the change order will be brought to the Board for approval prior to the work being performed.

**RESOLUTION TO APPROVE THE SALE OF THE KINDERGARTEN VILLAGE PROPERTY (2023-1355)**

WHEREAS, on September 27, 2022, the Clark-Shawnee Local School District Board of Education ("Board") took official public action, pursuant to Ohio Revised Code Section 3313.41 as well as Clark-Shawnee Local School District Board of Education Policy 7300, Disposition of Real Property/Personal Property, determining it to be in the best interests of the Clark-Shawnee Local School District, to dispose of vacant land owned by the Clark-Shawnee Local School District Board of Education ("Board"), [Clark County Auditor Parcel Nos. 3000700025000046, 3000700025000047 & 3000700025000108 consisting of 5.335 gross acres: 0.14 acre right of way and 5.190 net useable acres] located at 3858 Old Clifton Road and 3825 Old Clifton Road, Springfield, Ohio 45502, (hereinafter referred to as "Kindergarten Village Property"), by way of public auction pursuant to Ohio Revised Code Section 3313.41(A); and

WHEREAS, also pursuant to the Board's official public action on September 27, 2022, the Board established the fair market value of the Kindergarten Village Property, based on certified appraisal, to be two hundred thousand dollars (\$200,000); and

WHEREAS, also pursuant to the Board's official public action on September 27, 2022, the Board authorized the engagement of GovDeals as licensed auctioneers for the auction of the Kindergarten Village Property on the terms as presented by way of Memorandum of Understanding and Online Sale Terms and Conditions; and

WHEREAS, GovDeals conducted the public auction of the Kindergarten Village Property, which concluded on March 15, 2023, with the final bid of one hundred ninety-six thousand five hundred dollars (\$196,500); and

WHEREAS, pursuant to the same official public action of the Board on September 27, 2022, the Board declared that if the public auction of the Kindergarten Village Property was not successful, the Board reserved the right to sell such property at a private sale in accordance with the provisions of Ohio Revised Code Section 3313.41 and applicable Board Policies; and

NOW THEREFORE BE IT RESOLVED, by the Clark-Shawnee Local School District Board of Education ("Board") that the Board acts to accept the final bid of one

hundred ninety-six thousand five hundred dollars (\$196,500) at public auction for the successful sale of the Kindergarten Village Property;

BE IT FURTHER RESOLVED, that the Board hereby authorizes its President, Superintendent and Treasurer to engage in all activities, and to execute all documents on the Board's behalf, as required for the sale, closing, and transfer of title by quit claim deed of the Kindergarten Village Property to the successful bidder forthwith and consistent with the Online Sale Terms and Conditions of the Memorandum of Understanding with GovDeals.





In addition to this, students will experience the diversity of aquatic life through a snorkeling excursion. They will learn about sustainable farming. They will visit a wildlife refuge, a coffee plantation and thermal springs. They will also take a series of ecological workshops. This agreement for the provision of unbundled Internet access service ("Agreement") is entered into as of this 28<sup>th</sup> day of February 2023, by and between **Miami Valley Educational Computer Association** ("Provider") and **Clark-Shawnee Local School District** ("Customer"), as verified by the signatures on the signature page below.

**RECITALS**

WHEREAS, Provider is a regional educational center organized by the State of Ohio to provide communications and other technology services, and;

WHEREAS, the Customer is an educational entity in the State of Ohio, and;

WHEREAS, the Provider through its technology center desires to provide to Customer and Customer desires to secure from Providers the services detailed in this Agreement;

**TERMS**

NOW THEREFORE, in consideration of the mutual agreements hereinafter set forth and for other good and valuable consideration, the parties hereto, intending to be legally bound, agrees as follows:

**I. DEFINITIONS:**

As used in this Agreement the following terms shall be defined as follows:

*"Bandwidth Service Provider"* shall mean the vendor sub-contracted by the Provider to provide transport for the contracted bandwidth.

*"Services"* shall mean all of the duties and ministrations pursuant to Article III and Exhibit A of this Agreement.

*"User"* shall mean a school or person authorized by a school to make use of the data services or equipment secured by Customer from Provider by this Agreement.

## **II. TERM AND RENEWAL**

This Agreement shall be for the period beginning July 1, 2023 and ending June 30, 2026.

## **III. SERVICE**

Provider shall furnish Customer unbundled Internet access services as further described in attached Exhibit A.

## **IV. CHARGES AND PAYMENT**

Customer agrees to be solely responsible to Provider for all charges associated with the Services throughout the period of the Agreement regardless of the availability and/receipt of E-rate funding. Provider may, or may not, purchase transport through a third-party Bandwidth Service Provider. The cost of transport from the Bandwidth Service Provider may vary and will be passed through directly to Customer. Charges for the Services provided under this Agreement will be billed to Customer on a semi-annual basis.

Payment of all invoices for Services provided by Provider under this Agreement shall be due and payable within 30 days of the invoice date. Late payments shall be subject to a service charge of one and one half percent (1 1/2%) of any and all unpaid balance per month unless expressly waived by the Provider in writing. Provider may, at its sole discretion, terminate or suspend the Services to any Customer whose payments are in arrears by more than sixty (60) days. Such suspension shall not be deemed a waiver of other legal or equitable rights the Provider may have for enforcement of payment. If the Provider suspends Services to Customer pursuant to this Section, Provider reserves the right to charge Customer a reconnection fee to cover the administrative cost of reconnection. The reconnection charge shall be in addition to any other amounts owed to Provider by Customer.

## **V. WARRANTIES AND LIMITATIONS ON LIABILITY**

**A.** Provider shall not be liable for any damages incurred as a result of the errors, omissions or negligence of Customer, its personnel, employees, agents or users. Provider shall not be liable for failure to perform if such failure is caused by acts of God, winds, fires, landslide, floods, droughts, famines, acts of public enemies, insurrection, military action, sabotage, riots, or civil disturbances, failure of a utility or utility type service which is essential to the Provider's Service or other event(s) not reasonably within the control of the Provider.

**B.** Customer may utilize the Services provided for educational and educational administrative related activities only on its premises. Customer acknowledges that its access may be through a shared Internet network to the extent permitted by law.

Where the Services provided include access to the Internet networks, Provider does not warrant that the functions of the Internet network will meet any specific Customer or user requirements, or that Services provided will be error-free or uninterrupted; nor shall Provider be liable for any actual damages or any indirect, incidental, special or consequential damages (including as a result of loss of data or misinformation) sustained in connection with the use, operation, or inability to use the Provider Services by Customer or its users. Further, Customer understands and agrees that Provider will exercise no control over the information that Customer and users may transmit and access as a result of the provision of Services by Provider and that, therefore, Customer will make no claim against Provider for the Internet service uses, including transmission, downloading or uploading of information that is offensive, a violation of the law, or the actionable violation of others' rights. Unless special arrangements are made and appended to this Agreement, Provider will not routinely monitor Customer's activities or pupil access to any of the interconnected systems. Any filters or screening devices are limited to those in existence at the date of this Agreement or for which Provider subsequently installs. Provider is not under any duty to install or modify filters or screening programs. Provider does not warrant the accuracy or appropriateness of any information contained in the interconnected systems. Customer understands and agrees that the Internet, by its nature, is an open portal of content and material, some of which may be inappropriate for school-aged students.

**C.** To the extent that Customer, either directly or through its agents, permits student access to the interconnected computer system(s) of the Internet through Provider's Services, Customer assumes full responsibility and agrees to hold Provider harmless for any and all access to and usage of information contained on the interconnected computer system(s) of the Internet.

**D.** Provider or Customer shall not be liable for any damages incurred as a result of the errors, omissions or negligence of the other party, its personnel, employees, agents or users. Provider or Customer shall not be liable for failure to perform if such failure is caused by acts of God, winds, fires, landslide, floods, droughts, famines, acts of public enemies, insurrection, military action, sabotage, riots, or civil disturbances, failure of a utility or utility type service which is essential to the Provider's Service or other event(s) not reasonably within the control of either party.

**E.** Provider reserves the right to discontinue Customer's access to the Provider's Service and/or seek other legal or equitable relief for use of the Services that Provider deems to be in violation of the rules and regulations of the State Board of Education or any other state or federal agency; or in violation of this Agreement; or violate state or federal law; or are uncivil. For purposes of this Agreement, uncivil conduct includes, but is not limited to: 1) transmitting offensive or harassing statements; 2) developing and/or transmitting offensive or unlawful graphics; 3) transmitting sexual or ethnic slurs explicitly or as part of a joke; 4) soliciting or encouraging others to engage in sexual,

offensive or unlawful acts; or 5) permitting or encouraging unauthorized access to the Provider's network and public networks including unauthorized access to the Internet.

F. Customer understands and agrees that Provider shall have no responsibility for the accessing or transmitting of offensive or unlawful information by Customer or Customer's users, interference or unlawful access to others' information or networks, or other offensive or unlawful activity in which Provider's Service is used.

G. Although Provider does not have a duty to monitor Customer or its Users' transmissions, it shall not be prohibited from so monitoring.

## **VI. PROPERTY**

A. All written procedures and similar items utilized or developed in connection with this Agreement are the property of Provider. Customer hereby waives any rights whatsoever with respect to the property of Provider.

B. All Provider-owned equipment ("Service Equipment") shall irrevocably and under all circumstances remain with Provider and its designee, and Customer will protect Provider's rights, title and interest therein against all persons. Customer's interest in the Services and Service Equipment is limited to possession and use thereof on the premises.

## **VII. CONFIDENTIALITY OF INFORMATION**

A. Provider shall exercise reasonable ordinary care in preserving and protecting the confidentiality of information and materials furnished by Customer.

- c. **Captions.** The captions in this Agreement are inserted only as a matter of convenience and as a reference, and in no way define, limit or describe the scope or intent of this Agreement or any of the provisions hereof.

- d. **Rights of Persons Not Parties.** Nothing contained in this Agreement shall be deemed to create rights in persons not parties hereto.
- e. **Severability.** If any provision of this Agreement or the application thereof to any persons or circumstances shall, for any reason or to any extent, be held invalid or unenforceable, the remainder of this Agreement and the application of such provision to such other persons or circumstances shall not be affected thereby, but rather shall be enforced to the greatest extent permitted by law.

## **EXHIBIT A**

### **INTERNET ACCESS SERVICES**

This exhibit is hereby made part of the Internet Access Services Agreement (the "Agreement") entered between Miami Valley Educational Computer Association ("Provider") and Customer, as these terms are defined in the Agreement. The following additional terms and conditions apply to the Agreement.

Services will be rendered for the period of the Agreement, unless otherwise stated below. Any additional services will be billed monthly as incurred.

#### **1. Services**

The Services provided and their attendant costs are set forth on Schedule 1 and Chart A attached hereto and incorporated herein by reference.

#### **2. Installation Charges**

Customer agrees to pay Provider for any installation costs, if incurred, as a result of providing Services to Customer.

#### **3. Provider's Obligations**

- a) Provider will provide sufficient training of Customer's personnel to permit Customer to perform all functions and procedures associated with the Internet Access connection.
- b) Provider will plan and coordinate all activities incidental to the implementation of the Internet access connection.
- c) Provider will own and assume all responsibilities for the equipment and facilities which provide physical Internet access system up to and including the router included in any Internet access connection.

#### **4. Customer's Obligations**

- a) Customer will assume all responsibilities for all local area networks (LAN) connected to an Internet access connection. These responsibilities include, but are not limited to, Customer-owned communications equipment/cabling, LAN software, and LAN hardware.



- b)** Customer will provide surge suppression for all devices either directly or indirectly connected to the Internet access connection. The surge suppression must meet UL1449 rating.
- c)** Customer will make its personnel and records available to the extent necessary to facilitate the planning, training and implementation process of the Internet access connection.
- d)** Customer will provide Provider with appropriate and sufficient space and electrical power to facilitate the Internet access connection installation.
- e)** Customer agrees not to connect any of its local area networks to alternative Internet service providers without Provider approval.
- f)** At the commencement of the Agreement, Customer shall identify up to three individuals, subject to change at the discretion of Customer upon prior written notice to Provider, authorized to contact Provider or its subcontractors regarding support of the Service. Memorandum of Understanding

Clark-Shawnee Local Education Association

This Memorandum of Understanding is entered into on this 21st day of March, 2023 ("Effective Date") by and between the Clark-Shawnee Local Board of Education ("Board") and the Clark-Shawnee Local Education Association ("CSLEA") (collectively, "Parties") for the purpose of documenting mutual agreement to the payment of a one-time stipend to CSLEA bargaining unit employee Kate Johnson ("Teacher Johnson") for unforeseen and extra work performed during the 2022-2023 contract year as a result of the unexpected mid-year departure of a licensed intervention specialist assigned to a specific special needs classroom, and related to mid-year onboarding and mentoring of a newly-hired teacher to replace the intervention specialist who departed.

WHEREAS, the Board and CSLEA are Parties to Contractual Agreement(s) effective July 1, 2022 through June 30, 2025 ("Agreement"); and

WHEREAS, the provisions of the Agreement do not address the payment of a one-time stipend to any bargaining unit member for

performing unforeseen and extra work related to maintaining the workload of another bargaining unit employee who unexpectedly departs during the school year, or for performing extra work related to onboarding and mentoring of a new teaching employee, hired mid-year, to replace the departing bargaining unit employee and who is in the Resident Educator program; and

WHEREAS, Article 43 of the Agreement sets forth terms and conditions applicable to the Resident Educator program; and

WHEREAS, under the terms of Section C of Article 43, CSLEA bargaining unit employees who mentor one (1) newly hired teacher are to be compensated at .016 of the B.A. Degree (Class I, Step 0) rate and said amount is to be paid with the employee's regular paycheck; and

WHEREAS, the scope of specific mentor duties to be performed by Teacher Johnson for the newly-hired teaching employee for the remainder of the 2022-2023 school year is not yet defined or determined by the Parties; and

WHEREAS, the Parties wish to recognize and compensate Teacher Johnson for the unforeseen, extra work performed by Teacher Johnson during the second half of the 2022-2023 school year related to the

unexpected mid-year departure of a licensed intervention specialist assigned to a specific special needs classroom; and

WHEREAS, the Parties also wish to recognize and compensate Teacher Johnson for extra work performed related to onboarding and mentoring of a new teacher, hired mid-year to replace the licensed intervention specialist, and who is in the Resident Educator program;

NOW THEREFORE BE IT RESOLVED that the Parties mutually agree that bargaining unit employee Kate Johnson will receive a one-time only stipend in the amount of .016 of the B.A. Degree (Class I, Step 0) rate, in recognition of the unforeseen and extra work performed by Teacher Johnson related to the unexpected mid-year departure of an intervention specialist assigned to a specific special needs classroom, and for performing onboarding and mentoring of a newly-hired teacher to replace the licensed intervention specialist for the remainder of the 2022-2023 school year. The stipend set forth in this section shall be payable to Teacher Johnson through regular payroll occurring on June 20, 2023 and such stipend will not be paid by separate payment. The stipend will be subject to all standard payroll deductions and withholdings;

BE IT FURTHER RESOLVED that the Parties acknowledge and agree that the terms of this Memorandum of Understanding ("MOU") are non-precedent setting and do not create or establish any form or basis of past practice between the Parties as to the subject matters address in this MOU;

BE IT FURTHER RESOLVED that the Parties agree that this MOU shall expire at the end of the 2022-2023 contract year, with no further action required by the Parties.

The Parties each affirm that the terms of this Memorandum of Understanding were agreed to voluntarily and that the terms of this Memorandum of Understanding constitute the entire scope of understanding between the Parties as to the subject matters addressed herein. The terms of this MOU shall be binding upon the Parties upon execution and proper approval by the Parties.
