Manteca Unified School District utilizes extensive measures to gather and synthesize community input when developing all of its plans which includes local meetings at individual school sites (February - March 2021), input from parent groups within the district (School Site Councils, English Learner Advisory Committees, District Parent Advisory Council, District English Learner Advisory Committee), staff (including ACCESS groups) and community surveys (LCAP, California Healthy Kids, Individual school site) as well as other input. The Local Control Accountability Plan (LCAP), with a focus on English learners, low income and homeless students, and foster youth, as well as the COVID-19 Safety Plan utilize this input. The Facilities Plan is a comprehensive needs assessment which is consulted as facilities needs are identified. In addition, and prior to presentation of this plan, MUSD also consulted with representatives within our district of the Indian Education program (9/16/21), representatives for the migrant students within our area (9/22-27/21), English learners (9/30/21) representatives of students with disabilities who function in the schools within MUSD (9/24/21), and representatives of the National Association for the Advancement of Colored People (12/15/20). This plan was developed to build upon the vision and goals of the board of education in helping each student to achieve grade level standards, feel safe and be supported to realize individual success, understanding and focusing on the groups of youth previously identified as most impacted by the pandemic, the resulting school closures and interrupted learning.

A description of how the development of the plan was influenced by community input.

As MUSD worked to incorporate the health guidelines which resulted from the COVID-19 pandemic, input from community surveys and union groups was significantly considered, and a noteworthy need was improving indoor air quality to lessen the spread of the Corona virus or other airborne pathogens which compromise the health of students and staff. Teachers indicated the increased need for adequate tools for teaching their respective standards, and meeting the individual needs of students within their classrooms. In referencing "learning loss", the specific recommendations provided by individual groups of representatives of groups were taken in whole or in part and merged into this plan, where practicable. A significant request of each group which included parents was a continued focus on the mental health needs of students as they return to campus, and a continuation and/or expansion of extended day academic support services. Additionally, individual groups referenced a desire for greater access to tools which increase literacy, which reflect their unique cultures, and reflect the make up of the students in Manteca. Also, parents are requesting more specific training with a focus on the accessibility of information for parents in reference to student achievement, programs for which their students are eligible, and opportunities beyond the classroom.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
