PARKING PERMIT INFORMATION 2022-23

PERMIT MUST BE RENEWED EVERY SCHOOL YEAR

DEAR PARENT OR GUARDIAN:

Pursuant to Vehicle Code 21113, the parking regulations of Lathrop High School are as follows:

1. Parking is restricted for school use by students, school employees, and guests.
2. All vehicles must be registered with the Administration Office, and the LHS parking permit must be visibly displayed. Penalties for not having the vehicle registered or not displaying the permit are as follows:
 - a. Penalties range from detention to your vehicle being towed.
 - b. Continued infractions may result in revoking of driving privilege to school.
3. Guests must use parking spaces designated as Guest Parking. Visitors are required to register with the Administration Office upon their arrival on campus.
4. Parking outside of lines, or in unauthorized areas, may result in referral to the Lathrop Police Services for appropriate action.
5. Violators may be towed at the owner's expense.
6. While respecting the rights of responsible students to drive their cars to school with parental permission, the school also realizes that it is responsible for the safety and welfare of all students; therefore, during the school day on or around the school grounds and at all school-related functions, **students who drive recklessly, break traction, or speed will be penalized.** Penalties for not following school parking/driving regulations will include the following:
 - a. Each time a student is referred for a violation the penalty(ies) will increase in severity.
 - b. Penalties include detention, work detail, Saturday School, and suspension.
 - c. Loss of driving privileges might also be included as a penalty.
 - d. Parents will also be notified of such violations.

The school realizes that this is a very stringent policy, but it cannot stand by idly while our students endanger their own lives and the lives and well-being of others. Manteca Unified School District currently participates in preventive program aimed at keeping drugs and illegal weapons off campus by employing sniffing dogs. ***Be aware that these dogs will sniff any cars found in our parking lots for illegal substances, weapons, etc.***

LATHROP HIGH SCHOOL VEHICLE REGISTRATION FORM

Driving to school must be considered a privilege. Failure to abide by the following rules may result to parking permit being revoked. The cost/replacement of a parking permit is \$5.00.

1. The student must possess a valid California driver's license.
2. The student and vehicle must be covered by insurance which meets California law for financial responsibility. **Please bring in a new copy of insurance when it expires during the school year.**
3. The student and his parents or guardians must assume liability for damage to school property.
4. The school cannot be responsible for damage or loss to any vehicle brought to school.
5. The student must park in the prescribed parking area in the spaces designated for students. This includes motorized two-wheeled vehicles.
6. Vehicles are to be parked and not used during the school day except when prior approval has been granted by a parent or guardian and the school.
7. Vehicles may not be used to transport other students off campus without authorization from the school (i.e. checkout slip or off-campus pass).
8. Any parking permit which may be required must be displayed as prescribed by the school, but not in violation of the California Motor Vehicle Code.
9. A student driver must abide by the California Motor Vehicle Code and Lathrop High parking regulations
10. **PARKING PERMIT MUST BE RENEWED AT THE BEGINNING OF EACH SCHOOL YEAR**
11. **Please bring the following to the office when purchasing your parking permit**
 - a. **The form on the back side filled out and signed by you and your parent/guardian**
 - b. **Your CA driver's license**
 - c. **Current school ID**
 - d. **Current insurance**
 - e. **\$5**
