#### **Improve Achievement for all Students**

Continue to provide outstanding performing and artistic opportunities for students both in and out of the classroom: (in-district music concerts - Southeastern MA and State level music festivals: SEMSBA, District, All-State; music competitions, community performances; Art shows & competitions - MA Art All-State and juried art shows – (Boston Globe Scholastics, Emerging Young Artists, Josh Cutler Juried Art Competition, Keating Juried Art Competition).

#### **Support & Develop Excellent Instruction**

- Continue to refine and share best instructional practices
- Change/Pivot instructional model to comply with COVID safety protocols and mandates
- Continue to explore, purchase, and implement the use of technology in teaching and learning in the VPA classroom.

#### Align, Develop & Revise Curriculum

- Revise K-12 VPA course curriculum in all courses to align with new Massachusetts Arts Curriculum Frameworks including new standards in Media Arts.




## ARTS DISCIPLINES





The Framework shows a shift from the 1999 version by adding a new arts discipline. The Media Arts is now recognized as the fifth arts discipline, joining the previously established art forms of Dance, Music, Theatre, and Visual Arts.



## Media Arts Education

Encompasses interconnectivity across all disciplines and domains, artistic and academic elements, aesthetics and forms for the purpose of learning and creating

Intrinsically interdisciplinary, integrative, and expressive, inclusive of imaging, sound, moving images, virtual and interactive components.



An effective arts education enables students to become artistically literate.



#### Artistic Intent

An effective arts education develops students' understanding of the concept of artistic intent.



#### Coherent Learning

An effective arts education fosters a coherent and rigorous progression of learning.



## **FY '22 Costs for Preserving VPA Programs**

Budget Type	Description	Projected Cost
Textbooks	Music for band, orchestra, choral, and general music classroom	\$6,000
Instructional Materials & Supplies	All materials needed for teaching and learning- Majority of this cost is art consumables	\$33,000
Contracted Services	School-owned instrument repair and maintenance, art kiln maintenance, chair rental, piano tunings, accompanists.	\$12,500
Subscription Renewals	NAfME, NAEA, ACDA, MASSCUE, Music K-8, Music Express	\$3,800
Instructional Technology	Noteflight Learn, Smart Music, The Sight-Reading Factory, WeVideo, MusicPlay, among others.	\$6,800
