The Board of Education of the Troy City School District met in Regular Session at the Troy Board of Education, 500 N. Market Street., Troy, at 5:30 P.M. on Monday, April 10, 2023. - ❖ Gavin Palkovic, age 17, passed away March 6, 2023. Gavin was a student at Troy High School and the Upper Valley Career Center.
- ❖ Robert “Bob” Fletcher passed away on March 16, 2023 at the age of 80. Mr. Fletcher served as principal at Troy High School from 1981-1996. Prior to that, he was a social studies teacher (1967-1977), director of attendance (1977-1978) and assistant principal (1978-1981) at Troy High School. The Robert A. Fletcher Gymnasium (also known as the “auxiliary gym”) is named after him. Mr. Fletcher also was a member of Troy City Council and served as mayor of Troy in 1979.
