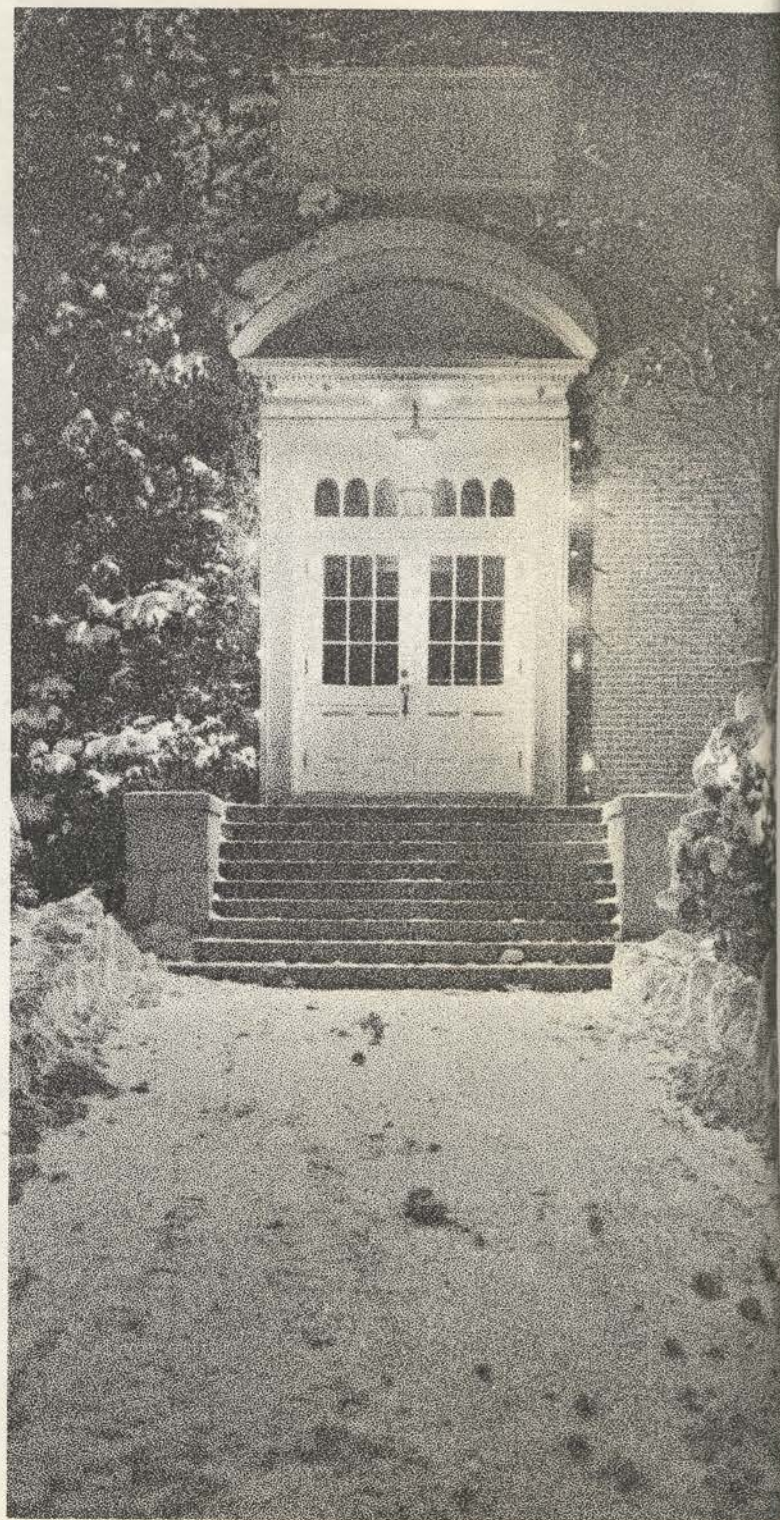

## A Message from the Headmaster

At this writing, campus activity centers on preparations for MCI's 104th Commencement Exercises, marking the successful completion of another in the 107 academic years since a small group of dedicated men secured a charter and the school enrolled its first class in 1866. The young men and women in the 1973 graduating class, led by David Reifschneider, Valedictorian and National Merit Scholarship winner, comprise a group in the best MCI tradition in whom we can all take pride. Like so many thousands before them, these young people take with them from MCI an experience, attitudes, and habits which will go far in determining the patterns of their lives.

Reflecting upon the year past—indeed on the century and more past—we inevitably ponder the ageless questions: Did MCI adequately prepare the members of this class for what lies ahead? Will these newest alumni be able to compete successfully—in college, on the job, in the armed forces—with young people from other schools, from other parts of the nation? Is the 1973 graduate as well prepared to seek his place in contemporary society as was the alumnus of 1873? Are the opportunities offered at our school keeping pace with the demands

of changing times; do they meet the needs of young men and women who will reach the peak of their productivity in the 21st century? While perhaps only the most fanatic partisan among us would presume to offer a definitive answer to questions such as these, it remains vitally important that they be asked.

It was after lengthy and careful consideration of questions like these that MCI's Board of Trustees made a decision to take a bold step forward in order to ensure that, despite quite serious economic pressures, our program would not suffer. Projected revenues over the next three years, while adequate to meet minimum needs—given further staff reductions and suspension of some programs—very clearly would not be adequate for the task of maintaining a superior secondary school program.

Rather than reduce further the size of the faculty, eliminate courses of study from the curriculum, and cut back on athletics, it was the Board's decision to launch an all-out capital funds drive in which every alumnus and friend of the school would be invited to participate. This decision, a watershed in MCI's long history, and based on a professional survey indicating that the MCI family has the ability to contribute several hundred thousand dollars to the school's development, has been followed by the building of an organization capable of making the

necessary contacts with alumni and other friends. A Council on Development appointed by President Herbert A. Leonard and headed by Campaign Chairman Ival R. Cianchette held its first meeting on March 17.

The Council, including representatives of the Board of Trustees, the Alumni, the Parents, the Faculty, the Community, and the student body, has responsibility for the fund drive's direction and policies. On March 24th, the New Opportunity Fund was publicly opened at a dinner for local supporters in the Parks Memorial Gymnasium. At that time, Mr. Cianchette was able to announce the receipt of gifts and pledges of more than \$118,000, an auspicious beginning toward meeting our needs which are estimated at \$600,000.

Hopefully, when this issue of the **Alumnus** reaches you we will have made significant progress toward being able to meet our need.

I urge each of you, on behalf of the youngsters who will rely on MCI for their secondary education in the years ahead, to support the New Opportunity Fund to the best of your financial ability. Without the support of hundreds of alumni giving at the level of which they are capable, we cannot succeed. With your support we can indeed provide "a New Opportunity" and continue to fulfill our "Honored Tradition."

MCI is in position to move forward and seize its new opportunity. The honored tradition of past achievement is a foretaste of what lies ahead.

Good working relationships have been re-established and senior high students of the Pittsfield area School Administrative District now attend MCI. Their return has brought a renewed spirit to the campus.

The administration of MCI's 15th Headmaster, Alfred I. Murray, is off to a good start.

There are many signs of progress:

The new work-study program sponsored by the Business Education Department with the help of local industry has been well received. Some of the girls placed in the six weeks of job training were hired permanently before graduation.

Co-education for boarding students has been re-established providing a more normal and attractive social and learning atmosphere.

Just over 90 per cent of those seniors who applied for college were accepted by the college of their choice. Many earned entry into the finest colleges in Maine and elsewhere. One senior was a National Merit Scholarship Finalist and recipient of a National Merit Scholarship.

The glory days of MCI athletics have certainly returned. Both boys' and girls' teams have winning records and placed in state championship tournaments. People in town are talking MCI sports. A P.G. football schedule has been planned for 1973.

While there is much to give encouragement, there is also one serious restraint upon further development. MCI's available resources were strained to the limit while the day student question was being resolved. It was necessary to borrow funds to maintain the quality level of education.

## THE NEW OPPORTUNITY FUND

The cost of the current indebtedness is a drain on the teaching budget. Removal of the debt will release funds for program enrichment. This is part of today's opportunity.

The Trustees decided to launch an all-out fund-raising campaign to meet the challenge. With the creation of **The New Opportunity Fund**, alumni, parents and other friends of MCI are being given the chance to ensure a bright future for a school that has given so many an "opportunity in life."

**The New Opportunity Fund** has begun in the Pittsfield area. A convocation was held in the Parks Memorial Gymnasium in April to explain the needs of the school and the plans for the future to Pittsfield alumni, parents and friends. A full report of **The New Opportunity Fund** will be presented in the **Progress Reporter**.



# The Needs to be Met...

The range of opportunities is wide. They touch all phases of MCI teaching, learning and living. The opportunities rise out of felt needs.

Certain of these needs are urgent and must be given priority attention. They constitute the immediate challenge of **The New Opportunity Fund**. These urgent needs amount to \$600,000.

## CURRICULUM ENRICHMENT \$80,000

**Choral and Instrumental Music:** Good music is part of MCI tradition. **The New Opportunity Fund** will bring a full program of music back into the curriculum. A full-time teacher and the necessary equipment will cost \$25,000.

**Industrial Arts Equipment:** This vocational field has advanced rapidly. New equipment must be obtained to keep the learning opportunity abreast of developments in industry. It will cost \$25,000.

**Business Education Facilities:** Modern office equipment, including data processing capability, must be provided for student training. The new work-study program with local firms gives this need a special urgency. Cost estimated at \$25,000.

**Adult Education:** A new program to serve the Pittsfield area. There will be classes in academic subjects for persons who want to complete or extend their high school education. Also gymnastics and body conditioning, sewing, woodworking, leisure interests and other subjects for which there is demand. \$5,000.

## ADMISSIONS AND COUNSELING \$40,000

MCI needs to attract more boarding students to make full use of its facilities and provide added income for the operations budget. The three-year cost for a full-time recruiter-counselor will be \$40,000. The investment should more than pay for itself in that period.

## SCHOLARSHIPS \$40,000

The MCI opportunity ought to be available to some deserving students who are unable to pay the full boarding costs. Additional scholarship funds are essential:

- to provide assistance out of operating budgets over a five year period — \$8,800.
- to endow scholarships for distribution after five years — \$31,200.

## FACULTY SALARY SUPPORT \$50,000

Reasonable salary support is required to maintain faculty morale and attract new competent teachers. The recent budget squeeze has made it impossible to give necessary increases and upward adjustment of salaries is now urgently needed:

- to provide increases out of operating budgets over a five year period — \$11,000.
- to endow faculty salaries for distribution after five years—\$39,000.

## RENOVATIONS IN CAMPUS BUILDINGS \$40,000

Attractive living quarters are an asset in the recruitment of boarding students and faculty. Well maintained administrative and teaching areas lift morale and efficiency. Sections of Alumni Hall and Founders Hall require renovation for greater usefulness. The estimated cost is \$40,000.

## MORTGAGE REDUCTION \$350,000

Significant reduction of the mortgage will release current interest payment funds for program development and personnel support. As soon as \$350,000 of the mortgage is paid, the \$29,750 annual interest will be available for program enrichment. There after the mortgage will be of manageable size.



E. Robert Kinney, MCI Class of 1935, has been elected president and chief operating officer of General Mills, Inc., Minneapolis, Minnesota.

A native of Burnham, he attended and graduated from Bates College after MCI. He attended Harvard Graduate School.

E. Robert Kinney was elected a member of the board of directors and executive vice president on November 24, 1969. He was named chief financial officer in December, 1970. In this position, Kinney has responsibility for the overall coordination of financial, control and corporate development activities. He had formerly been responsible for the company's consumer food operations. He became a Vice President of the company on September 25, 1968, a month after The Gorton Corporation merged with General Mills.

Kinney, who joined The Gorton Corp. in 1954, served as its president since 1958.

Kinney is a trustee of Bates College, Maine Sea Coast Missionary Society, George Putnam Fund, the Putnam Growth Fund and the Minnesota Outward Bound School. He is a director of Nashua Corp., Jackson Laboratory, Putnam Investors Fund, Putnam Voyager Fund and Putnam Income Fund. He also serves as a director and member of the executive committee of both the Tyrone Guthrie Theatre and the Minneapolis YMCA.

Bob has been a loyal and active alumni of MCI over the years. He is currently serving as co-chairman of the Leadership Gifts Committee of The New Opportunity Fund.



# Levels of Giving Explained...

"Everyone must give according to his financial ability if we are going to obtain \$600,000 in gifts to meet the urgent needs," Chairman Ival R. Cianchette said to the Council on Development at its February meeting.

"Experience in hundreds of similar campaigns indicates that between 80 and 90 per cent of the total given must come from 10 to 15 per cent of the donors who have the ability to give \$1,000 or more over a three year period," he explained.

"Success depends both on securing at least twelve pledges between \$10,000 and \$75,000 and on securing several hundred pledges of one to five Shares. This pattern of support is a reflection of the distribution of wealth and income in the nation," Cianchette said.

Pledges are payable over a three year period. In most cases this will cover four tax reporting years.

All contributions to The New Opportunity Fund are deductible on the federal income tax.

Pledges below \$1,000 are known as Share Gifts. A Share is a unit of giving. It is a gift of \$180 payable over three years. This is \$5.00 a month for 36 months.

Many multiple Share pledges are needed. A pledge of five Shares represents \$25 a month or \$900 total. Two Shares is \$10 a month; three Shares is \$15 a month.

"The Challenge Gift range is from \$1,000 to \$9,900. At least 140 Challenge Gifts are needed. A pledge of \$5,000 paid over three years represents \$416 a quarter," Mr. Cianchette said.

Pledges of \$10,000 or more are Leadership Gifts which must yield 45 per cent of the total given.

The Council on Development adopted a Scale of Gifts for success of The New Opportunity Fund campaign.

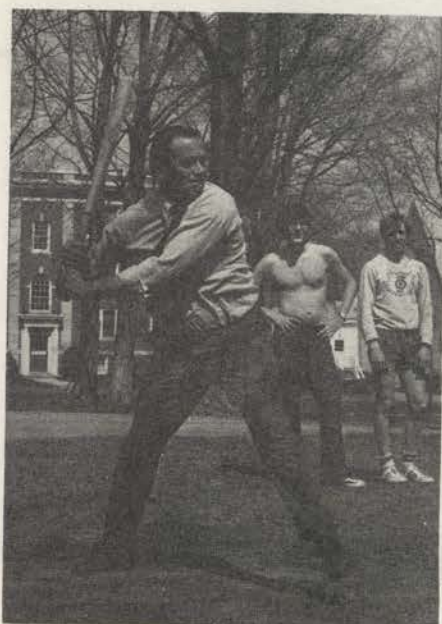

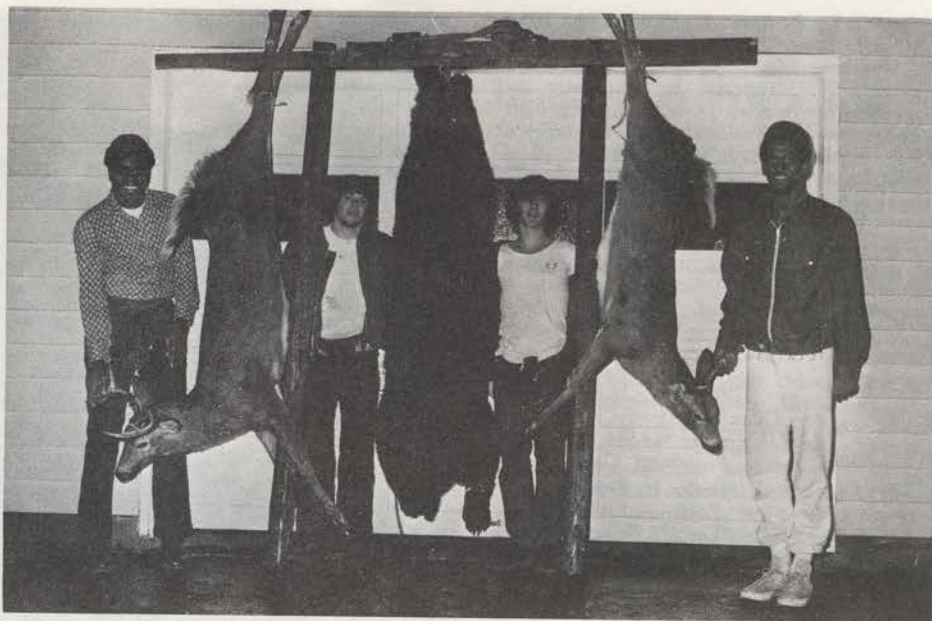

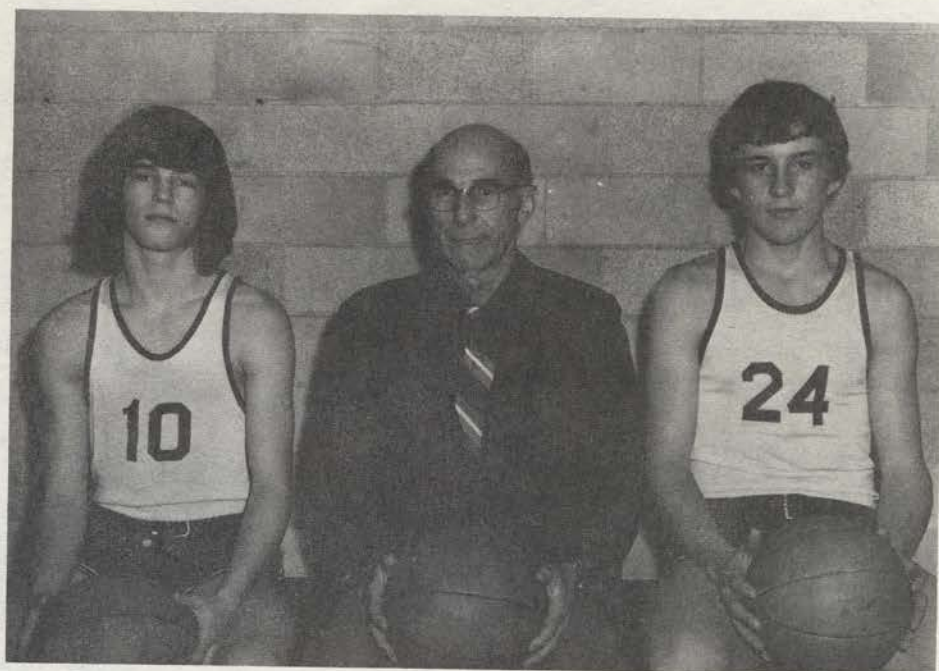
