

The President's Page


Last year, John Furbush '34 opened his report as president with this sentence: "Probably no MCI Alumni Association president has ever been able to give a more encouraging report at the beginning of a new year than I can give you." I am happy to be able to tell you that I can top his excellent report in every department. In 1952, your Association more than quadrupled the 1951 Alumni Fund, while the number of individual donors was 94 greater than in the previous good year. Building on the fine work done in 1951, your officers in 1952 were much encouraged by your loyal support.

True, we did not reach the goal of \$5,000 set at the time of last year's annual meeting. But we did come encouragingly close to that goal. The \$3,964 in the 1952 Alumni Fund was equal to the income on an endowment of \$79,000, and this is no negligible sum. This year, we will try once more to reach the \$5,000 goal; I do not for a moment doubt that we shall succeed.

Perhaps the most encouraging single feature of last year's Alumni Fund was the fine showing made by the MCI Builders. These nineteen men and women deserve our highest praise for their support of a new idea, designed to make it possible for the Association to render real help to MCI and its boys and girls. I sincerely hope that 1953 will see an even more impressive list of Builders; I know that many of you will want to join this fraternity.

Scarcely less encouraging were the increases in the number of givers and in the average gifts. A few hundred-dollar givers can start an alumni fund off in grand style, but when all is said and done, it will still be the larger number of donors of a dollar or five or ten or twenty who will make the Fund what it must be — a concrete representation of the overall support of all the Alumni for a school they respect and want to help. Not all of us can give in large amounts, but few of us are unable to give.

Elsewhere in this issue of the *Alumnus*, you will find reports covering the disposition of the Alumni Fund. I think you will agree with me that the Association has made a very worthwhile contribution to MCI. I know that school officials are tremendously encouraged to receive our sup-



port; I know too that the type of youngsters receiving scholarship aid as a result of our efforts is the type that makes one glad he chipped in, if only a little.

The annual Homecoming last August was most successful. I went, and I'm glad I did. Everyone I met seemed to share my opinion. Certainly the banquet was tops; I doubt that a similar meeting in a great metropolitan area could expect to receive finer food, more tastefully served. As usual, the number attending was not as great as we wished. However, with those who attended having such a good time, we expect a greater number this year. I hope you will plan to save the first Saturday in August for the 1953 Homecoming. It will be a reunion year for the 3 and 8 classes, with top honors going to 1903 on their fiftieth, but we hope to see many back from other classes as well. If you plan to come and want to see a good representation from your class, why not drop Mr. Stanley a line? He'll be glad to help you get in touch with your classmates, and he'll appreciate any help you can give him in his efforts to produce a crowd.

I hope all of you will enjoy this issue of the *Alumnus*. If you have any suggestions about ways of improving the magazine, or about your Association's program, please get in touch with me. It is your Association, and we want you to find in it a good medium through which to keep in touch with MCI, still the best prep school in Maine.

THE MCI DEVELOPMENT COUNCIL

Your Association, at its annual meeting in August, 1951, voted to instigate the formation of an MCI Development Council, whose purpose it would be to raise funds for the School. The initial meeting of this group was held at MCI on May 13, with Everett S. Hurd '13 presiding.

Stanley, alumni secretary, reported on the origins of the council and gave a thumbnail sketch of the condition of the School, with particular emphasis on the School's need for better financing and additional facilities. His report was supplemented by remarks made by Principal W. Howard Niblock. During discussion

following these reports, various suggestions were entertained as to ways and means of creating interest in MCI on the part of prospective donors.

Housewife in the Headlines

The little town of Warren, Maine, made news in '52, when a housewife from that community travelled to fabulous Arden House in Harriman, New York, to address the American Assembly, a program which aids U. S. citizens in making up their minds on major issues of the day. Eleanore Davis Perkins '39, the wife of the principal of Warren High School, Fred L. Perkins, Jr. '38, accepted the invitation of Lewis W. Douglas, former American Ambassador to the Court of St. James and chairman of the national policy board of the Assembly, to discuss inflation from the point of view of an American housewife.

Mrs. Perkins not only addressed the Assembly, but she did so effectively. In her audience were some of the nation's foremost men in the fields of economics and finance, to whom she gave the studied viewpoint of an American woman who must translate their scholarly findings in trends, rates of exchange, etc., into the everyday terms of stretching the paycheck so it will cover the essential food needs of the family.

Mrs. Perkins' address was buttressed by months of diligent study on her part. Both the theory and the practical sides of inflation were the subject of her closest scrutiny during the period of her preparation. The result was an address worth listening to, from a woman who had both studied and experienced her subject.

The American Assembly itself is one of the most promising developments in the American scene. Started in 1950 at the instigation of President Eisenhower, who came back from Europe troubled that his citizen-soldiers were so confused over the important issues of the day, the Assembly seeks to bring together representative citizens and recognized authorities, in order that both might benefit from a mutual interchange of ideas. Mr. Eisenhower recognized that the roots of the problem he sought to solve lay in the small cities and towns of America, that it was not a problem to be solved by adding a new course to the undergraduate curriculum at Columbia, which he then headed. The result was the American Assembly, a forum meeting twice each year at Arden House, a mansion donated for that purpose by W. Averell Harriman.

Offshoots of the parent body, local "American Assemblies" in miniature have been started in many communities. The first such group in New England was formed in Mrs. Perkins' home town of Warren by the Warren Women's Club, of which she is an active member. This group attracted the interest of Dean Philip Young of Columbia University's Graduate School of Business, who is in charge of the administration of the American Assembly. As a consequence of his

Leon R. Rowe '92 -- Exporter

(Editor's Note: The following autobiographical notes were kindly provided by Leon R. Rowe '92 in response to the alumni secretary's request for news of the interesting life that has carried Mr. Rowe from his birthplace in Newport, Maine, to his present residence in Buenos Aires.



I am including a short biography of my family, as it now seems very typical of the students of the M.C.I. sixty years or more ago. I do not remember the name of a single student at that time that was not English. There were Robinsons, Folsoms, Denekers and Prescotts, all names of families with which my own had intermarried at some time in the preceding century. So we all had a very similar background.

The earliest knowledge I have of the Rowe family is the first visit of the King's Herald to Devonshire in 1520, when they found Sir John Rowe, whose family is recorded in subsequent visits to 1705, when Robert Rowe, the third son of the Sir John Rowe of that period, lost his wife and sailed for the Barbadoes. In 1707 we find him living in the parish of Kensington, now North Hampton, N. H., where he married his second wife, Aphia Leavitt, and whose will was probated in 1754. From him was descended my grandfather Edward Rowe, who about the beginning of the nineteenth century married Hannah Lane, and packed his worldly belongings and his bride on two horses, and with two cows migrated to a hill near a small lake in East Pond Plantation in the Province of

Maine, following a trail marked by trees spotted by his brother and himself the previous summer. This place is in the northwestern part of the town of Newport and I believe is still called Rowe's Corner. Here my father was born in 1822 and married my mother, Helen Burton, in 1853 — or just one hundred years ago. I was also born in Newport, in 1875, but unlike my father and grandfather, did not spend my life there.

The two years after my graduation with the class of 1892, I was at a loose end. A close friend of my father's came near inducing me to enter the medical profession — which, I believe, would have been a serious mistake as I am a very unobservant person and could never have been a reasonably good diagnostician. I did consider it seriously enough, however, to spend a winter in the Staten Island drugstore of a cousin of my father, studying anatomy and materia medica.

The next spring I returned to Maine and took a course in the Bangor Business

interest, the Warren assembly has had the benefit of the presence of representatives of the American Assembly on several occasions. It was one of these representatives, hearing Mrs. Perkins speak on inflation to her local group, who was responsible for bringing her to the attention of the top echelon in the Assembly. The result — an invitation to be the main speaker at the opening session of the American Assembly in December, 1952, where she spoke along the same lines of her talk back in Warren.

Since her return from the Assembly, Mrs. Perkins reports, she has been deluged by speaking engagements. High on the list of these in the coming months is an engagement to address the State Federation of Women's Clubs at their annual session.

Black '15, Ambulance No. 1, 26th Division, AEF . . . About twenty MCI girls were meeting regularly in a Pittsfield office to make surgical dressings for the Red Cross . . . MCI defeated Bangor High in basketball, 50-16. Breen, at center, was top man for MCI with 9 points . . . Marion Griffin '14 was serving as a substitute teacher in the absence of Miss Fisher, instructor in public speaking . . . MCI boys were making money and helping hang the Kaiser by cutting wood at three dollars a cord on weekend wood-chopping bees to help alleviate the coal shortage . . . During the 1918 basketball season, MCI racked up 321 points against 263 for its twelve opponents . . . Walter M. Burse '16 was elected president of the Maine Club at Brown University . . . Ferne Shaw '15 entered Bliss Business College in Lewiston . . . The Amicimian Society was in full swing as an organization for boys interested in public speaking, debate, and parliamentary law.

Candidates for the mound as the season opened were Roy Milligan of Danvers, Mass., Ken Sargent of Bangor, Phil Huff of Pittsfield, John Springer of Danforth, Albert Bailey of Pittsfield, and Ralph Smith of Exeter . . . Marguerite Tozier and Kenneth Burns were in charge of the program at the annual Junior May Ball . . . Eunice Reed of McKinley was the sole veteran on the varsity debate squad . . . A pair of recent graduates were doing well in track at Bates — Jere Moynihan in the polevault and Royce Purinton in the hurdles . . . Gardner Rufus Burns '27 was chosen by the faculty at Springfield College as one eligible to a national honorary society . . . Thurman Larson, a freshman at Bowdoin, broke the all-time freshman shot put record with a heave of 48' 4", while Nelson Tibbetts broke the 1000 yard run record . . . The girls' basketball team won nine of their games, losing only three. Louise Lagorio was their captain . . . The boys' basketball team closed their season with a 56-32 win from Coburn, winning nine and losing four in the season . . . Ruth Webber won all but one of the girls' ski and snowshoe events in the annual winter carnival . . . The varsity coaching staff included Roy U. Sinclair as coach of football, Russell Fitz as assistant football coach, and Sanger M. Cook '17 as coach of track.

The Alumni Scholarship Fund



A Letter from Connecticut

(Editor's Note: Each year many thousands of letters arrive on campus, addressed to the principal of MCI. The one printed below stands out, not only because the writer is this June celebrating his seventieth anniversary as an alumnus, but also because he expresses a faith in MCI that should be an inspiration to all who read his words. The Reverend Roscoe Nelson was ninety-one years old last October; a week after his birthday, he occupied the pulpit in Windsor, Connecticut, the same he served for more than forty years. MCI salutes Mr. Nelson and wishes him many more years of fruitful service.)

My dear Mr. Niblock:

I have been reading again the "Lost Potential" story which came some weeks ago. It brings back a scene in the little chapel in 1880. I appeared there with the hope I would be allowed to stay. Mr. Bachelor, the Principal, somehow found me and proceeded to quiz me — what I had been doing, where I came from, etc.? I told him I had been working as a carpenter in Bangor. I had no more than said the words before he said, "That was the trade of Jesus. He was a carpenter." That was rather new to me, and the way he said it seemed to make the impression on me that the same Jesus was not a far away person but one quite vitally present.

That first interview seems, as I think of it, to have touched a major note — maybe the keynote — of the school. Mr. Bachelor was my teacher for only about a year — maybe a little more. And he was a rarely gifted teacher. The Greek language was, to him, not dead but alive. At our graduation he came back from the college in Michigan and preached the baccalaureate. I remember vividly at this moment his

closing sentence, "As to discouragement, trust in the Lord."

I must not presume upon your time to read my memories of the long ago. I am more aware of the fact now than I was in my days there that the school was founded as a Christian school. No boy or girl could long be there without becoming aware that, to the MCI faculty at least, the Christian religion was something pretty central for human life. I doubt not the same holds for the present faculty. And that fact — as well as others — defines the mission of the school in this time, as at the beginning.

I am sending you a small check. If you have a scholarship fund, maybe you will put this into that fund. Others will provide the buildings, in time. We had but one building, and a good school.

You will pardon my rambling letter.

The Lure of the Middle East

The Middle East seems to have a fascination for MCI alumni. Last year, you may recall the *Alumnus* reported the activities of Ewart Hodgins and Douglas Sinclair, both '42, in Saudi Arabia. Now the *Alumnus* brings you the news of the departure of Arthur W. Danielson '33 for Tehran, the capital of Iran.

Mr. Danielson, the superintendent of schools in Somersworth, New Hampshire, until February 1, 1953, is going to Iran under the Point Four Program. After some weeks of orientation at the Office of Education (FSA) in Washington, D. C., and some months additional orientation and specialized training in Tehran, he will embark on his new duties in an outlying district, probably near the Persian Gulf.

Mr. Danielson's work will be concerned with organizing Iranian education. Since there is presently but one high school in all Iran, the instigating of the establishment of additional facilities will form a major part of his duties. His official title will be

"Specialist in Educational Material and Staff."

Mr. Danielson is being accompanied by his wife, the former Hope Flanders, and their son David, now in his freshman year in high school. Plans have been made to enroll David in the Presbyterian High School in Tehran, the nation's only secondary school; next year, if Mr. Danielson is transferred to another part of Iran, David's education promises to be a problem.

Since graduating from MCI, Mr. Danielson has received his B.S. degree from Bates College and his M. Ed. from the University of New Hampshire. He has also attended summer sessions at the Oswego, New York, Normal School. He has taught at Mexico, Maine, and Ipswich, Massachusetts, high schools and has been principal at Pittsburgh and Bethlehem, New Hampshire, high schools. He was superintendent of schools in the Newmarket-Epping district in New Hampshire before accepting his most recent post at Somersworth.

Cook '17 in March 1953, this trophy will be awarded annually to the boy who, in the judgment of the head coach of track, is the most outstanding in ability and team spirit. As a basis of judgment, the following criteria have been set up: (1) points scored, (2) conscientious training, (3) attendance at practice, (4) team spirit. The donor of this award, a former Bowdoin College pole vault champion, was for many years head coach of track at MCI, where he turned out superior teams and earned an enviable reputation as one of Maine's outstanding track coaches.




MCI closed the 1952 football season with a 16-0 victory over Higgins Classical on Armistice Day to earn the mythical Maine Prep School title for the second successive year. For Head Coach Nels Corey, the season marked his third championship at MCI in as many years as coach. Corey, who returned to MCI after three years as assistant coach and head coach of football at Colby College, has the enviable record of nineteen wins, one tie, and but one defeat with the MCI Huskies.

Opening with a 47-7 victory over Bridgton Academy, the Huskies suffered their only loss in the next game, when they fell before the Maine Maritime eleven, 25-6. After that, the squad made it five straight: MCI 45, Maine Frosh 0; MCI 34, Colby Frosh 6; MCI 27, Hebron 0; MCI 67, Bates Frosh 0; MCI 16, Higgins 0.

Although they scored 242 points to their combined opposition's 38, the Huskies had to depend on seventeen or eighteen players, making the two-platoon system an impossibility and requiring very careful utilization of manpower. The combination

of a strong line and a well-trained backfield, however, was enough to turn the trick, despite the fact that MCI's schedule was, as usual, the toughest faced by any Maine prep squad.

Starting linemen were Capt. Thurlow Cooper of Augusta and Maurice Dore of Skowhegan as ends; David Fenderson of South Portland and Lawrence Goodwin of Augusta at tackle; Hamilton Grant of Westbrook and George Pierce of Portsmouth, N. H., at guard; and Peter Kostacopoulos of Pawtucket, R. I., at center. In the backfield were Quarterback Robert Pickett of Augusta, Halfbacks Richard Merriman of Bangor and Clifton Gage of Pittsfield, Fullback Joseph Vachon of Saco. Reserve strength included Charles MacDonald of Wells, Paul Kimball of Skowhegan (son of Stanley Kimball '31), Donald Irish of Auburn, and Edward Manson of Winthrop in the line. Reserve backs included Bernard McGowan of Skowhegan, Alfred Seymour of Gardiner, Joseph Cabrera of Portsmouth, N. H., Joseph Pardini of Pawtucket, R. I., and John Minott of South Portland.

Winning the Northern New England Championship in basketball for the second successive year, the MCI Huskies also won the State Prep School title for the third successive year, retiring the University of Maine's impressive five-year trophy.

The state title was won after MCI gained the finals by defeating Fryeburg Academy, 85-54. In the finals, the Huskies took a nip-and-tuck victory from Higgins, 87-85, to give them a clean slate in the three games with Higgins this year.

Four days later, the Huskies travelled to Exeter, N. H., to meet Tilton School in a play-off game for the New Englands. With Capt. Peter Kostacopoulos of Pawtucket, R. I., setting the pace, the team defeated Tilton, 78-65, to give them the mythical Northern New England title and the right to play Dean Academy in the semi-finals of the New Englands in the Boston Gardens. There MCI was defeated, 77-63, by the team that went on to win the New England crown.

In the regular season, Coach Bert Pratt's squad dropped their opening pre-Christmas games to Maine Maritime Academy, then won the remaining thirteen games. With

two wins each from Higgins, Coburn, Bridgton, and the Colby Frosh, and single wins from Hebron, Kents Hill, Husson College, the Bates Frosh, and the Maine Frosh, the season ranks with the best MCI has ever experienced.

A tall and talented senior from Bath, Jack Hartleb, sparked the team throughout the season, tallying 365 points in the nineteen games and hitting in double figures every game but one. Runner up to Hartleb was Pickett of Augusta, who scored 253. Other first string performers, all with fine scoring records, were Capt. Peter Kosta copoulos, Thurlow Cooper of Augusta, Maurice Dore of Skowhegan, and Charles McInnis of Portsmouth, N. H. Equally important were Coach Pratt's very dependable reserves — George Newhouse of Pittsfield (son of Herbert Newhouse '23), Gary Goodrich of Pittsfield (son of Guy Huff '18), Victor Hoyt of Easton, William Sullivan of Bingham (brother of Elizabeth Sullivan '51), and Paul McKeen of East Wilton. from the organization, which until then had been about half American and half German. To this I had no complaint, as my settlement was perfectly satisfactory.

I then formed a partnership with a man who could supply all the capital we needed. This arrangement continued until 1918, when I decided to form my own company.

I went to Europe in March, 1919, and landed at Rotterdam the first shipment of Cotton Waste that reached the continent after the War, in July of that year.

The next seven years were the most interesting of my life. I spent one in Rotterdam, three in Hamburg, and three in Milan, returning about three times a year to the U. S. A.

Since my venture in foreign trade, I have done business in fourteen countries of Europe, five in South America, as well as in Canada, Mexico and the United States.

My impressions over the last thirty-five years have convinced me that the people with whom I have been in contact are fundamentally much the same everywhere. They are all keen to take advantage of the foreigner, as honest as they think expedient, and all complain about their climate. To the last I must except the people of Los Angeles, who are certainly great boosters for theirs. My first visit there happened to be in the middle of the rainy season. I was told they had not had such a rain since some date twenty years or more earlier — and I have been told the same story each time since then, when I was there in the rainy season.

My first European trip was a series of blunders. I wanted to go first to Holland, but some wise fellow told me to go to England, from where I could get a boat across every day. So I took a Cunarder which landed me in Liverpool — which is about as far from Amsterdam as any port in Western Europe. I then found out that my visa to enter Holland was only good from the U.S.A., also that there were only two boats a week. And when I had at last another visa — which at that time required two days — and could get a boat, I had lost nearly a week, and instead of going through that night we were held at Tilbury until daylight, as the North Sea was so rough that it loosened the mines

that hadn't yet been cleared by mine sweepers. I was told that we sighted three, although I only saw one, which had been reported to a British naval vessel, which exploded it with a shot.

Arriving in Rotterdam just as it was beginning to grow dark in a fall of damp snow which had already accumulated a couple of inches of slush on the streets, and going to a hotel that had only a little heat in one room was one of the most dreary introductions to a trip one could imagine.

A few days later I went to Amsterdam, where I learned that the N.O.T. (Netherlands Overseas Trust) would not allow Cotton Waste to be sent to Holland, although it was badly needed.

The N.O.T. was an Allied Organization which controlled the importations to Holland of all essentials, and was supposed to make its allotments impartially. It was staffed largely by British, and my experience led me to believe that it was run principally in the interest of British trade.

From Holland I went to Belgium, France, Switzerland, Italy and Spain, with nothing unusual occurring, with the exception of interminable delays in getting the necessary visas, and arrived in New York on June 12. There I was informed that the N.O.T. would probably cease to exist at the end of the month, and so I booked space for as much Cotton Waste as the companies would give me on the first two boats for Holland leaving after July first.

I left again on July 16 for Holland, arriving two days after my first shipment, and sold it all that same day. This was the most profitable single sale in my life.

There was nothing particularly outstanding on this trip, except perhaps my trip from Berlin to Hamburg. The train left at six o'clock, and I was told to go to the station at three and get as near the edge of the platform as possible. When I arrived I could hardly get into the station. In the next hour or so I got to the ticket window and, as the trains were leaving frequently, I got to the edge of the platform at just about six, when a train pulled in and I, like many others, scrambled in through a window. In two or three minutes there were as many in the car as could get in — four times as many in my compartment as it was supposed to hold.

I went to the Atlantic Hotel in Hamburg and asked for my reservation, and I was told that I had none. The hotel had been booked full for three weeks and there would be nothing available for at least two weeks and possibly three. I was very disappointed but went for something to eat, and then by great good luck took a seat not far from the room clerk's desk, where I could see what was going on. I had not been there long, when a man came up and started talking. Everything seemed to be going all right till he took a twenty mark note and pushed it across the desk. The clerk pushed it back as though it were the filthiest thing possible, and contemptuously turned his back and walked away.

I waited a while and when there was nobody around I went over to the desk and gave a little spiel and took two one hundred mark notes and slid them towards the clerk. With a deep bow he inquired whether I wanted something on the front of the house or the back, and said they had a nice suite on the corner of the first floor. I took it and it consisted of an enormous livingroom, a large bedroom, dressingroom and bath—as large as many rooms in good hotels in the States—and cost me about \$5.00 a day. That was when I learned what was the only reservation that counted—a lesson that only failed me once in the next three years.

The inflation of the mark was now well started and it continued until Dr. Schacht brought in the Reichsmark, worth 4.20 to the dollar. Shortly before this the mark had reached a low of four million two hundred thousand million marks (4,200,000,000,000,000).

The effect of this on the economy of the country has been so well written up that it is useless for me to try to add anything. There are, however, two phases resulting from government acts I have never seen mentioned. The fixing of rents, and the method of assessing taxes.

Each month the government fixed the amount payable in marks for any rented property, regardless of the amount previously agreed upon. In 1920, I took a suite of three offices, about 800 square feet, for which I agreed to pay the equivalent of \$10. Before the war the rental had been about \$37.50. In two or three months, the government decreed the rental should

be about fifty cents per month and this continued for nearly three years. The first month after Dr. Schacht's Reichsmark it was \$7.50, the second \$37.50, the next \$75 and again the next \$150. Then I left Germany for Italy and have no idea what it was after that.

Taxes were assessed in this manner. The policemen of the better class neighbourhoods were called to the tax officer's office. They were asked what they knew of Herr S. He perhaps would say that he thought Herr S. was having a rather difficult time. That he had not gone away for a summer vacation. He had not entertained for a year, and the butcher said he was having trouble to collect his bill. Herr S. was then scratched from the list. They would go on with varying reports till they'd come to a Herr Y. Then the policeman would perhaps report that Herr Y's family had gone to the Baltic for the summer and had spent the winter in Italy and had given several large parties. On this report they would assess him a tax of perhaps a million marks. He would then protest that it was a mistake and the bill was not intended for him. They would insist that it was intended for him and that he should pay the assessment; then he would come back and say that he did not have a million marks, he had never had a million marks and all he could do was let them put him in prison. They would send him home and tell him to come back at the end of the week with what he could pay and they would try and extend the time for payment of the balance. After badgering him for weeks or months and deciding how much they could get from him, they would tell him 100,000 marks was the minimum and if he would pay that in seven days they would let him off—otherwise they would send an officer for him.

I avoided this racket by forming a corporation (M.b.g.H.) with one officer in U.S.A., another in Saxony and only the secretary in the jurisdiction of the Hamburg assessors.

The only other thing of real importance that happened to me during my stay in Hamburg was on a trip leaving the States October 20, 1920, on the old steamer "Rotterdam," I met the lady who some years later became my wife, nee Annie von Maibom. It is possible some of my

readers feel more or less acquainted with her as she has had about a dozen mystery novels published in the U.S.A. and nearly as many in England, writing under the name Anne Rowe.

Life in Hamburg at this time was very pleasant and extraordinarily cheap. The residential part of Hamburg is the most beautiful of any city that I know and the strange thing about this is that of the thousands of tourists that formerly passed through the city probably not one in a hundred knew it existed. In the centre of the city are two lakes, the Binnen Alster which occupies perhaps a hundred or more yards of one side of the Jungfrausteig, the principal shopping street of Hamburg, and practically connected with it, the Ausser Alster, which reaches into the best residential district.

Leading from the Ausser Alster and the River Alster which feed the two lakes are innumerable small canals, some natural and some artificial. These run at the back of fine homes facing on two streets. Nearly all of these homes have a finely kept lawn running to the canal and most of them have their private pier at which are tied a canoe and a small sail boat, as sailing on the lakes is a major sport and on days with sufficient wind there will be hundreds of sails of some type or another to be seen.

The thing that gives almost unbelievable charm to a trip through these little canals is that in front of most every window is a large window box filled with trailing geraniums that in late summer drop down fifteen or twenty feet profusely flowering with a peculiar bluish pink blossom which makes every yard which is separated by hedges a veritable stage setting.

It was with sincere regret that I was compelled to leave Germany but with the stabilization of the mark came a determined effort to drive all foreigners out of the country and particularly those in business. This was accomplished by sending unreasonable tax bills. If you paid

them promptly you received a supplementary bill; if you did not pay them promptly you were fined.

I left Germany in the winter of 1923/4 and went to Milan. This was not as agreeable either as a place to live or to do business. I knew no Italian and although my German was very bad I could get along in a business conversation but not in a social; nevertheless, it was much better than nothing.

In business my most important customers for American waste were in Poland and the people from whom I bought for export to America were in Germany or Transylvania, both more difficult to reach from Milan than from Hamburg.

I remained in Milan until 1927 when I returned to Boston staying there one year and then going to New York, staying until 1940 when I made a connection to open a waste department for Woonsocket Top makers with my office in Boston. This only lasted a year owing to incompatibility of personalities.

I then started my own firm again in Boston and continued until 1946 when I removed to Brazil, and came to Argentina in 1949 and am doing business in this country, which has its advantages and disadvantages. The greatest advantage is that the living here costs approximately 25% of what it would cost in a sizeable city in America.

I find the life here very agreeable and expect to continue to do business here indefinitely, but of course there is always the possibility of some change of law or conditions that will force me to leave as I was forced to leave Germany; but if such a thing happened it is difficult to say just where I would go as with the world conditions as unstable as they are at present it is very difficult to decide what place offers most comfort and security.





to the powerful joint Committee on Appropriations and Financial Affairs, the joint Public Buildings and Park Committee, and the Commission on Interstate Cooperation.


