## A Message from the Board President and Superintendent

Dear Longwood School Community,

After more than a decade of advocating for equitable funding, we are pleased that New York State is fulfilling the promise to fully fund the Foundation Aid formula enabling the District to offer the second-lowest levy increase to our community in more than a decade, less than one percent.

The Board of Education adopted a proposed budget of \$291,000,000 on April 18, 2023. This year, residents will be asked to vote on the proposed budget on Tuesday, May 16, and vote for two candidates running for the Board of Education.

This year's proposed budget reflects our ongoing commitment to build upon past successes to support a strong and diversified educational program for our students while maintaining our fiscal responsibilities to our community.

As part of the District's long-term strategic plan, we will continue to work on our overarching goals of strong curriculum, instruction, and assessment practices; empowered students, staff, and school community; collaborative school and community partnerships, and efficient and effective operations.

This fiscal plan will continue to increase STEM and career and technical opportunities for our students, along with early intervention programs and high-quality professional development for our faculty. We will continue our campus branding and beautification projects and expand upon our uniform communication system, ParentSquare. Also included in this year's budget are increased mental health services and the implementation of additional school safety measures. Please take a moment to review the complete list of this year's budgetary items in this newsletter.

Our community continues to demonstrate incredible support and dedication to our schools, and we are grateful for our partnerships with our students, staff, families, and community. We look forward to our continued work together to ensure all of our students reach their full potential.

Remember, your vote – every vote – counts! As always, we sincerely thank you for your ongoing support of our students, our schools, and the entire Longwood School community.

#### **Budget Vote**

Voter Registration: Registration is available at the Office of the District Clerk, 35 Yaphank Middle Island Road, Middle Island, Monday through Friday between 8:30 am - 3:00 pm, Central Registration, 15 Everett Drive, Yaphank, Monday through Friday between 8:00 am and 2:30 pm, or at any one of our schools during school hours. Registration is also available through our website at www.longwood. k12.ny.us - On the home page, click About, Budget 2023-2024, and follow the links to Voter Registration. The last day to register to vote is May 11, 2023.

Voter Eligibility: You must be a citizen of the United States, 18 years of age or older on the day of the vote, and a resident of the Longwood School District for at least 30 days prior to May 16, 2023.

Absentee Ballots: Applications can be found on the website under District - 2023-2024 Budget - Voting Information. Absentee Ballot Applications cannot be accepted prior to April 17, 2023. Applications must be received no later than May 9th if the ballot is to be mailed. Applications must be received by the day before the election, May 15th, if the ballot is to be personally delivered.

# Our Students Excel in Academics, Athletics, Music and Fine Art, and Community Leadership

# **Academics**

Graduation rates reached 91% in 2022, up from 83% in 2013.

More than 120 students in the Class of 2022 graduated with the Seal of Biliteracy, and Longwood High School received the Silver Milestone Badge from the New York State Department of Education for its Seal of Biliteracy Program.

Students receiving Advanced Regents Diplomas have increased 70% since 2013.

Seniors received more than 250 credits through the Early College Entrance Partnership Program.

The Junior High School maintains its position as one of only 30 New York State Elite Schools designated as an Essential Elements School-to-Watch.

Our High School Robotics team earned the Team Spirit Award for extraordinary enthusiasm and spirit for their exceptional partnership and teamwork.

# **Athletics**

Ninety percent of our high school student-athletes were named NYSPHSAA Scholar Athletes for earning a 90 or above.

The boys and girls varsity bowling teams captured Suffolk County Bowling titles, and represented Section XI at the NYSPHSAA Bowling Championships, earning sixth and second place, respectively.

A senior received the NYS Football Coaches Association 12th Man Award, given to an athlete who overcomes adversity or medical hardship.

The varsity football team was a Suffolk County Championship Finalist and Big Four Champions, ranked #18 in New York State.

Three seniors were also named to the New York System Sports Writers Association All-State Team.

A senior won the Suffolk County Girls Singles Tennis Championship, finishing #2 in New York State.

The Unified Sports Program participated in a local Youth Summit, sponsored by Special Olympics.

The varsity girls' flag football team continues in its second season after being awarded emerging status by New York State Public High School Athletic Association.



The varsity girls' volleyball team were League I Champions for the first time since 1999, with their head coach earning Coach of the Year honors

The JV boys soccer coach was named JV Coach of the Year by the Suffolk County Soccer Coaches Association. The team was awarded the JV Sportsmanship Award from the Suffolk County Officials Association.

# **Music and Fine Arts**

The District's music education program received NYSSMA's Award of Excellence.

For the fifteenth consecutive year, the District has been named among the "Best Communities for Music Education" in the nation as designated by the NAMM Foundation.

Seventy-three students were selected for the Suffolk County Music Educators Association's All-County ensembles in band, chorus, and orchestra.

Four students were selected to the New York State School Music Association's All-State Festival in Rochester, NY.

Two seniors performed in the National Association for Music Education's All-National Festival in Grand Harbor, MD.

Three students performed in the National Association for Music Education's All-Eastern Festival in Rochester, NY.

One senior performed in the New York State Band Directors Association's Honors Jazz Ensemble in Syracuse, NY.
