<u>GOAL MONITORING SESSION</u> – Goal 1: K-5 Literacy Proficiency. Board President Woolley gave a brief update regarding the fundamental goal monitoring questions to be considered during the discussion.

Dr. Marshall shared that Josh Jacobs, a graduate of McLain High Schools, is continuing to break records and to demonstrate what can be achieved. As a Las Vegas Raider he rushed for a league-high 1,402 yards in the regular season, average a 107.8 yards per game, and according to the NFL became the third running back in the Super Bowl era with at least 300 scrimmage yards and two touchdowns in a game.

Mr. Croisant gave a shout out to the Edison Pom team for finishing as State champions of 5A.

Ms. Woolley mentioned her excitement regarding the addition of the Cherokee, Muskogee, and Osage Nation flags that are erected in the Cheryl Selman room. She also shared that tribal flags are erected at the schools within the district residing on native lands.
