# THE BOARD OF EDUCATION OF INDEPENDENT SCHOOL DISTRICT NUMBER ONE OF TULSA COUNTY, OKLAHOMA MINUTES OF THE REGULAR MEETING OF JANUARY 9, 2023

A regular meeting of the Board of Education of Independent School District Number One of Tulsa County, Oklahoma, was held on January 9, 2023, commencing at 6:31 p.m., in the Cheryl Selman room, ground floor, at the Charles C. #### STAFF REPORT

#### **BOARD MEMBER REPORTS**

Board Member Judith Barba Perez announced her resignation from Board District Two seat after nearly two years of service. She stated that she was grateful to have had a part in making Tulsa Public Schools Board of Education meetings a place where more families and students feel comfortable to attend and share their voices. Due to an opportunity for her family out of state, she announced her resignation from her seat effective January 23, 2023, following the regular meeting of the board.

Board Member Jennettie Marshall shared that she had the opportunity to attend the parent academy at the parent resource center. She spoke highly of the speakers and offerings and encouraged families to take advantage of this resource. She also spoke of a visit from the creator of the Greenwood Avenue Project and encouraged the public to see it when it returns to Tulsa.

Mr. Croisant shared that a Tulsa World article referencing the recent collapse of athlete, Damar Hamlin hit close to home. He referenced a similar incident with an Edison student athlete who collapsed after practice. He credited coaching staff and an AED defibrillator with saving that students life. He thanked those in the district for providing life-saving training and AED defibrillators to all of our coaches and schools throughout the district.

Dr. Gist recognized the board in honor of National School Board Recognition Month. Additionally, she congratulated the Class of 2022 winter graduates, the students participating in the Tulsa Debate League and the athletes placing in tournaments across the State.

# OTHER NONROUTINE ITEMS REQUIRING BOARD ACTION

Board President Woolley shared information and requirements, referencing Title 26 section 13A-110 of state statute, regarding the process for addressing vacancies during a board member's term.

L.1 Recommendation: Accept the resignation of Judith Barba Perez, Board of Education member representing Election District Number Two, to be effective January 23, 2023, after the adjournment of any meeting of the Board on such date, and to declare such office to be vacant.

Mr. John Croisant made a **motion** to accept the resignation of Judith Barba Perez, Board member representing Election District Number Two, to be effective January 23, 2023, as stated in the language of the recommendation in agenda item L.1, and the motion was **seconded** by Dr. Jennettie Marshall.

Dr. Jerry Griffin made a motion to **amend the motion** on the floor to "accept Ms. Barba Perez' resignation effective tonight" (January 9, 2023.) Ms. E'Lena Ashley **seconded** the motion.

Legal Counsel advised that the amendment was not appropriate in that the Board of Education cannot determine Ms. Barba Perez' or any individual board members resignation effective date.

Board President Woolley opened discussion of the further recommend establishing the date the Board of Education would receive written applications until January 31, 2023, at 5:00pm.

Board Member Croisant made a **motion** to approve, and Board Member Ashley **seconded** the motion to set the written application deadline as January 31, 2023.

The board had discussion on this motion. The motion failed with the following vote:

Dr. Marshall stated in the past the process was to allow all applicants an opportunity to speak at a board meeting following the close of the application submission deadline. Subsequently, she stated that interviews with the full board and applicants were held resulting in the narrowing down of the applicant pool to two for consideration.

Board President Woolley stated that if the motion on the floor is approved, the board would schedule all applicants an opportunity to speak at the January 23, 2023, regular meeting of the board.
