

AISL School Fee Information



Please find information about AISL school fees for the 2023-24 academic school year. This information includes general guidelines about payment of school fees and discounts for “Private Payers**”.

The itemized breakdown of school fees for the 2023-24 school year shall be:

AISL does offer a Learning Intensive Focus Tutor program (1:1 tutor) for students who require an individualized learning program. Students who would benefit from this program are typically identified during the school admissions process. This is a fee based program.

AISL School Fee Information



General

1. The School shall issue invoices in Naira.
2. All invoices can be paid in Naira or USD.
3. The School shall determine the Naira invoice amount on the 25th day of each month and, if the 25th day is a weekend or holiday, then the School shall determine the Naira invoice amount on the next working day.
4. All invoices are due within 30 days of issue.
5. The School shall charge a \$1,000 non-refundable deposit fee per child to secure enrollment for the following academic year. The deposit fee is due by the end of the business day on Friday, June 9th. The deposit fee shall be deducted from the school fees.
6. The School shall refund School tuition fees by the Quarter.

Discount For “Private Payers*”

1. A 10% discount will be applied to Tuition only if “private payers” choose to pay school fees in US dollars. Installment plan with surcharges would still apply through to the end of April 2024 (the last installment payment). The 10% Tuition discount in US\$ would not apply to the outstanding balances remaining after April 2024.
2. “Private Payers” have the option to pay the One Time Registration Fee (\$10,000) over a two year period at \$5,500 per year.
3. “Private Payers” who wish to pay in Naira must contact the Business Office.
4. “Private Payers” may elect to pay tuition fees in installments by signing an installment plan agreement with the Business Office for the 2023-24 school year. For installments, the following rates apply for a one-off annual surcharge: \$500 for monthly, \$350 for quarterly, and \$250 for a semester. The School shall charge a lateness fee of 1% per month on the total amount due after the invoice due date.

**If the invoice is issued in the name of the parent/guardian, then that parent/guardian shall be considered a “Private Payer”.*
