November 9, 2020

The District 4 Board of Trustees held its regular meeting Monday, November 9, at 6:00 p.m. at Woodruff Elementary School. Agenda notice was distributed to Spartanburg Herald Journal, Woodruff Times, and listed on the District website at spartanburg4.org/do/agenda.

Chairman Melvin Brewton called the meeting to order. Minutes of the October 5, 2020 meeting were approved as submitted.

The following reports were given:

Woodruff Primary School

Mrs. Dover gave the following report:

- 1. Calendar of Events for November 2020 is attached.
- 2. Second grade CogAt and Iowa testing will be completed during the week of November 9th.
- 3. Teachers are completing parent conferences. Conferences have been held in person, by phone, or video conference.
- Second grade classes learned about leadership and held student council elections in class. Woodruff High School

Dr. Aaron Fulmer reported the following: Calendar of Events and Enrollment was distributed.

- 1. On October 7 and 8, Woodruff High School participated in College Application Day. Seniors were assisted by WHS guidance staff in filling out college applications.
- 2. The PSAT was administered at Woodruff High School on October 14, 2020.
- 3. First nine weeks report cards were issued on October 21, 2020.
- 4. Seniors completed the state mandated Ready to Work Assessment on October 28 and November 5.

Instructional Reports

Dr. Kim McAbee reported the following:

- 1. District Four received an "All Clear" status from the Office of Federal and State Accountability at the SC Department of Education based on the accreditation and monitoring desk audit conducted during the 2019-2020 school year. Every fifth year, the SCDE examines district databases and analyzes evidence to determine compliance with the SC Accreditation Standards. This deep dive audit was conducted last November. All submissions were accepted without corrections or the need for additional evidence. These results will be included in the 2019-20 Annual Report of the Accreditation of School Districts in South Carolina, which will be submitted to the State Board of Education on November 10, 2020.
- 2. Induction contract teachers continue to meet monthly to learn the requirements of the SC Teaching Standards 4.0 Rubric and Expanded ADEPT, the SC teacher evaluation system. The next Induction class will meet on Tuesday, November 17th in the Woodruff Elementary School Media Center. The November session will address trauma informed practices and trauma sensitive practices as they relate to the environment domain of the SC Teaching Standards.
- 3. Principals have completed all teacher orientation sessions as required under the Expanded ADEPT Evaluation System. In addition, they are finalizing Student Learning Objectives (SLOs) and Professional Goals with teachers. Principals and teachers will review progress toward those objectives and goals mid-year.

- 4. Eleven employees with educator licenses expiring in June 2021 are completing coursework or collecting renewal credits. Educators must have the equivalent of 120 renewal credits to renew a license for an additional five-year period. They must also meet the Read to Succeed requirements for their certification areas.
- 5. Interim reports will be issued on Wednesday, November 11th.

Mrs. Britt McKinney provided the following information:

- 1. DHEC administered 145 flu shots/mist at Woodruff Middle School on October 19th and 20th. This event was open for all children in the Spartanburg District Four area. The clinic was set up in the carline and stayed open from 3:30-6:00 each night.
- 2. The adult education program being offered at Woodruff Primary School is serving one student in the morning classes and one student in the evening classes. This program is led by Spartanburg County Adult Education and continues to take interested candidates. More information about enrollment and requirements are on the district website.
- 3. Spartanburg Four continues to report the number of COVID cases to DHEC in a timely manner and also updates can be found on our district website for the current number of cases in the district.
- 4. Title I, Title II, and Title IV will have a monitoring visit in March of 2020. Principals and other administrators will gather data, information, and complete inventory checks to complete this process for compliance.
- 5. All budgets have been submitted for the FY2021 school year. The state department is still in the process of approving local plans, but Spartanburg Four has not been notified of any issues with our submissions.

Mrs. Jennifer Turner provided the following information:

- 1. Woodruff Primary School continues to checkout iPads to students. The original 450 Chromebooks continue to be delayed and currently have an estimated arrival time of December.
- 2. Students with no internet at home continue to checkout mobile hotspots. At present, 348 students have a district assigned mobile hotspot in use at their home.
- 3. The 45 Day Student Count has been successfully completed and we await submission to the South Carolina Department of Education for the 2020-2021 year.
- 4. PALS and KRA state mandated testing for 4K and 5K completed on October 19th. PALS (4K) will complete a mid-year screening in January.
- 5. Second Grade CogAT and IA testing continues at Woodruff Primary School. These tests are used as identifiers for the Gifted and Talented program.
- 6. Woodruff Middle School eighth graders (A students only) and Woodruff High School tenth grade students participated in the PSAT on October 14th. Woodruff Middle School (B students only) and make-up testing for Woodruff High School will be offered on January 26th.
- 7. Woodruff High School's senior class completed the Ready to Work test on October 28th and November 5th.
- 8. The 2020 South Carolina School Report Card released to the public on October 30th. These report cards do not reflect any overall rating but display graduation rates, student safety, teacher and administration retention, and other financial and classroom details.

Ms. Rachel Traynham provided the following report:

1. Virtual Education Day

a. Special Education Teachers were asked to provide a description of the instruction they provided on Thursday, October 29th, when students were home due to Hurricane. I was very pleased with the information I received from teachers. Almost all our Special Education students were able to access the curriculum they were to be working on and were able to reach their teachers if they had guestions. Parents were comfortable

calling teachers and it seemed to be a success for Special Education students. Those students who were unable to access the curriculum that day had issues with power or slow internet connection possibly due to the wind. That was recorded and comp services will be provided as needed.

2. PPE

a. I placed a request with Mr. Simpkins for SPED teachers to received PPE offered from the state. Some of that has come in and we are distributing it to aid in student and staff safety during small group instruction.

3. Mental Health Counseling

a. Brenda Lipe and an intern therapist from Spartanburg Mental Health are working in our schools (primarily Middle and High School) two or three days a week until our two position within Spartanburg Mental Health are filled.

4. Whitlock/Brookwood/McCarthy Teszler

a. All students have returned to 5 days a week instruction.

5. Indicator 13

- a. We will have an Indicator 13 Audit due in November. This Audit impacts the Middle and High School because it examines IEP's for transition age students
- b. We are reviewing student files currently to submit those by the deadline

6. Special Education Roundtable

a. We were able to go to Columbia, Friday for a state-wide meeting for Special Education Directors. The state is sharing how students who earn a credential impact graduation rates as well has best practices to reduce drop-out.

7. Spartanburg Special Education Director Meeting

a. We will meet this Thursday, November 12, 2020, in Spartanburg School District 1

Facilities

Board members received a printed update of facilities projects.

Superintendent

- 1. The Spartanburg County Oversight Committee, which oversees disbursement of the 13 mils, will meet Thursday Nov. 12 at Chapman High School. Chairman Brewton will represent District Four.
- 2. The SCSBA Delegate Assembly is virtual this year. Sandy Norman is the voting delegate.
- 3. Copies of revised policies will be provided to board members at the December meeting.
- 4. The SCSBA annual convention will be held in February 2021. The space is limited to 300 board members to be present.
- 5. Gave brief update on possible return to full time after Thanksgiving.
