Frequently Asked Questions

Are there any capital projects included in the budget?

Yes, funds are included for the possible acquisition and renovation of a building. In addition, funds are included to complete Phases I and II of the High School turf field project. This will include the soccer stadium, press box, pavilion and the football field. In addition, funds are included to expand storage areas at Sonderling and Loretta Park.

Are there any multiyear deals in the budget?

Yes, the district will look to save taxpayer dollars by entering into multiyear deals in the following areas: copiers, software programs, curriculum items, secure socket layer certificates, hardware items, storage containers and mail machine.

What is a contingency budget?

A contingency budget is the maximum amount authorized by law that a district can impose on the community if the school budget is voted down. Since our proposed tax levy increase is currently 0%, the levy amount would remain the same; however, we would be forced to uphold certain expenditure caps, and the state would impose controls on all capital projects and severe restrictions on the use of school facilities by community members. The Board of Education may choose to make reductions or eliminate programs, which could include the summer recreation program, instrumental music and extracurricular activities.

Points of Pride

- Established the first High School Spanish Theater – Teatro Mundo de Los Suenos.
- Established a Kindergarten Spanish Language Immersion Saturday Program.
- District has first participant in Regeneron International Science and Engineering Fair.
- District has first recipient of the J100-AFROTC Scholarship.
- BHS boys varsity basketball won its seventh Long Island championship and competed in the New York State basketball semifinals.

- BHS varsity cheerleading performed at the Universal Cheerleading Association National Championship competition for the third time in program history.
- BHS wrestling team won Suffolk County Section 11 League Championship and earned first individual championship in girls varsity wrestling.
- The Brentwood Business Institute opened in September, providing students interested in financial disciplines with a more appropriate environment to learn about stocks and portfolio planning.





The Proposed 2023-2024 Budget Includes:

- Middle schools will transition to a nine-period day.
- More electives and Regents-level courses will be offered at this level.
- Security improvements include additional cameras, blue light system, vape/aggression detectors and door security improvements.
- Additional mental health support staff.
- Expand faculty to combat learning loss and provide tutoring.
- Secondary highlights: Virtual Enterprise and Financial Literacy offerings, robust credit recovery program, more AP courses and early-college offerings, enhanced career pathways, exceptional growth in the Seal of Biliteracy credential.
- Elementary Highlights: new reading program, additional reading and math specialists, new science curriculum and instructional specialist, late buses will be added, many Saturday Academy programs.
- Special services highlights: expansion of the Early Intervention Program, introduction of skills assessment to identify students' strengths and competencies, wraparound services to support mental health needs.
- Capital projects will continue throughout the District, including parking lot renovations, home economics kitchen improvements, cafeteria improvements, locker room renovations and much more.
