IV. New Business

- a. CA Dashboard Review – The Dashboard is used as an accountability measure for KCUSD
- b. Mr. Guzman reviewed the Dashboard and shared comparative examples from other Districts. KCUSD scored well in several areas but Mr. Guzman acknowledged that there are areas we need to improve. We are currently building in supports to help increase lower scores.

We currently qualify for Differentiated Assistance and are taking advantage of that support.

- c. CTE (Career Technical Education) Pathways – All students should have the option to attend college, however, students also need to know that they have CTE options too.

Currently at OCHS & RHS the following CTE programs are available:

OCHS - Firefighting Pathway, Arts, Media, Entertainment & Design, Robotics & Engineering, Patient Care Pathways, Food Service & Hospitality, Manufacturing, and Public Safety & Criminal Justice.

RHS – Child Development, Culinary Arts, Public Safety/CSI, Industrial Technology & Design, Engineering & Architecture, Cabinetry, Construction, Video Game Design & Video Production, Ag Mechanics, Animal Science, Ornamental Horticulture, Flight Science & Aviation, Automotive, Fire Fighting, Patient Care, Ag Studies, Arts Media Entertainment, Graphic Design.

Middle Schools – Elective wheels have been introduced, however, we would like to do more.

Elementary Grades – How do we get CTE awareness out to the younger grades earlier?

Parent asked if they could have CTE Elementary Field Trips.

Mr. Heinrichs suggested that as we are having construction projects carried out at our school sites we could invite a representative from the company to come and speak to the students about construction as a career choice.

- d. Children’s Day, April 27th, 2023 @ OCHS 4:30pm – 7:30pm
During this event we will honor our reclassified English Learners. Many of our students will participate in the event and there will be several resources available for parents.
- e. LCAP Input – Table Groups were given the opportunity to record any ideas that they may like to see included in the LCAP. Mr. Guzman will read the feedback and then take the information received to the Board for consideration and possible implementation at the right time.

V. Open Agenda

Parent inquired about Parent University. Mr. Durazo gave a brief report on Parent University and advised that the next sessions will start on 3/6/2023 and 3/7/2023 with additional courses starting in April. The parent spoke very positively about the class and shared that she had taken the ‘Small Business’ course.
