I understand that I must follow the following rules:

1. Speed limit is 10 mph
2. All state driving laws apply. Students in violation may be ticketed by the SRO.
3. An IRHS student parking pass must be displayed on the rear-view mirror, or clearly visible through the front windshield at all times.
4. Parking spaces are assigned. Students may only park in the student parking lot in their assigned space unless prior permission is granted from a Constable, SRO or Administrator.
5. In-School or Out-of-School Suspensions could result in losing parking privileges.
6. Student drivers must use the assigned entrances and exit areas to access the student parking lot.
7. Students are NOT to go to their car during the school day unless they have permission from a Constable, SRO or Administrator.
8. Students are responsible for any and all items inside their vehicle. ALL VEHICLES BROUGHT ON CAMPUS ARE SUBJECT TO A SEARCH.
9. Students and passengers are not allowed on campus before 7 a.m. without prior permission.
10. All Student Handbook and IRSD Rules and Regulations apply at all times.
11. Unauthorized parking and/or repeated parking violations may result in the vehicle being towed at the owner's expense, disciplinary action, and/or loss of driving privileges.
12. The school campus is private property. In the event of an accident between drivers, the drivers are to exchange insurance information. In the case of an emergency or injury call 911 and contact the SRO.
13. All students leaving early must have prior permission and sign out in the main office.
14. Student drivers will no longer be listed on the IRSD bus rosters once the parking permit has been issued.
