AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Yakima School District No. 7 from September 1, 2017 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body fundraising activities at Eisenhower High School – approvals, profit estimates, inventory, and cash receipting
- Cash receipting at Washington Middle School – timeliness and completeness of deposits
- Procurement – public works and purchases
- Tracking and monitoring of theft sensitive assets, such as technology related items
- Accounts payable – fuel cards
- Associated Student Body accounts payable – general disbursements and credit card purchases
- Compliance with bond covenant requirements
- Financial condition and fiscal sustainability
- Student enrollment reporting – special education

INFORMATION ABOUT THE DISTRICT

Yakima School District No. 7 operates 24 schools to provide educational services to approximately 15,400 students in Yakima County. Services include basic elementary, middle school, high school, vocational education, vocational skills center, alternative schools, bilingual education, pupil transportation, food services, magnet schools, special education and remedial and enriched education programs. In addition, the District provides transportation vehicle repair services.

An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations as well as its 1,750 full- and part-time employees. The District operates on an annual budget of approximately \$220 million.
