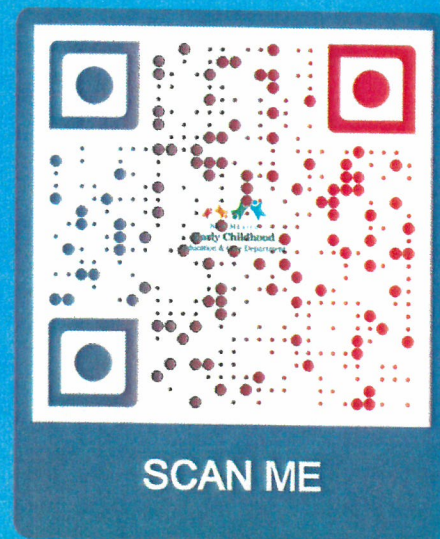

Desde el comienzo de la emergencia de salud pública, los proveedores de cuidado infantil de Nuevo México han atendido al público.

El estado de Nuevo México, asociado con proveedores de cuidado infantil, ha desarrollado unas de las reglamentaciones de salud y seguridad más claras y detalladas del país. Así, los proveedores de cuidado infantil han mantenido bajos los casos de COVID.

- Lavado de manos
- Medición de la temperatura
- Limpieza y saneamiento
- Distanciamiento
- Uso de mascarillas
- Respuesta rápida y pruebas si hay un caso positivo

Para pedir asistencia, debe presentar:

- Prueba actual de ingresos
 - Comprobante de nacimiento de los hijos de su hogar
 - Comprobante de actividad educativa/horario escolar para adultos (si corresponde)
 - Identificación con fotografía del solicitante
 - Comprobante de residencia en Nuevo México (contrato de alquiler, factura de un servicio público, hipoteca)
 - Información de contacto del proveedor de cuidado infantil elegido

Ampliación de elegibilidad

A partir del 1 de agosto, Nuevo México aumentará los ingresos familiares elegibles para recibir asistencia de cuidado infantil, que pasarán del 200% del nivel de pobreza federal al 350%, con un límite gradual del 400%. Así, un aumento moderado de sus ingresos no anulará su derecho a recibir asistencia.

Estos cambios contribuirán a aumentar el acceso y la calidad de la industria del cuidado infantil en el estado. Además, ayudarán a eliminar las barreras que podrían impedir a los residentes de Nuevo México reincorporarse a la fuerza de trabajo a medida que se reduzca la pandemia y se reabra la economía.

Since the beginning of the public health emergency, New Mexico's child care providers have been open for business.

The state of New Mexico—in partnership with child care providers—have developed some of the clearest, most detailed health and safety regulations in the country. As a result, child care providers have kept COVID cases low.

- Handwashing
- Temperature-taking
- Cleaning and sanitation
- Distancing
- Mask-wearing
- Rapid response and testing if a positive case occurs

Here's what you'll need to apply:

- Current proof of income
- Birth Verification for all applicant household children
- Verification of Educational Activity/School Schedule for adults (if applicable)
- Picture ID for Applicant
- Proof of New Mexico Residency (lease agreement, utility bill, mortgage)
- Contact info for selected child care provider (If you need help selecting a child care provider, please call Child Care Resource and Referral at the number below.)

Expanded Eligibility

Beginning Aug. 1, New Mexico will raise Child Care Assistance income eligibility for families from 200 percent of the federal poverty level to 350 percent of the poverty level -- with a phase-out at 400 percent of the poverty level, meaning a modest increase in income won't mean losing access to assistance. These changes will help increase access and quality in the state's child care industry and help remove barriers that could prevent New Mexicans from reentering the workforce as the pandemic subsides and the economy reopens.
