



## DePaul Catholic High School 2023-2024 Tuition-Enrollment Agreement

- The Parents and Student shall comply with all rules and regulations of the School, as set forth in the Student and Parent Handbook, and as amended from time to time at the sole discretion of the school administration. It is further understood and agreed that in the event the undersigned default or fail to fully perform all of the obligations hereunder, DePaul Catholic High School shall be under no obligation to render further services to the Student, and said default or failure by the undersigned will constitute a valid reason for termination of the Student by DePaul Catholic High School.
- In consideration of enrollment by DePaul Catholic High School of the Student as a member of said class for the stated period, we jointly and separately agree to pay tuition and fees to DePaul Catholic High School according to our selected Tuition Payment Preference Plan. It is understood and agreed that if a student's account is not paid in accordance with the payment schedule, the student may not be permitted to take mid-year or final exams, participate in school athletics or activities, receive a diploma, and may not be permitted to continue attending DePaul Catholic. If said Student ceases to be a member of the class before the end of the school year, tuition will be paid for the full semester during which the Student withdraws or is dismissed.
- It is further understood and agreed that the continuance of the Student as a member of said class is contingent upon maintenance of academic standards as established by the School. The judgment of the properly constituted School authorities shall be final and binding on all school matters. Promotion to the next class is conditional upon execution of a Tuition Agreement with regard to the tuition and fees and adherence to the terms and conditions set out herein. This shall not be construed to constitute a guarantee that the payments will remain the same for the succeeding year. It is understood and agreed that any Student deemed eligible for DePaul Catholic High School Tuition Assistance must maintain a GPA of 2.0 or better, and not be on disciplinary probation for the duration of the school year. The Student's tuition account must be kept up to date. Failure to maintain these conditions will result in the rescinding of Tuition Assistance.
- The signing of this agreement allows for the privilege for the Student to take part in school extracurricular activities. The undersigned hereby agree that the Student may

participate in all School activities, including athletics, and any school sponsored trip away from campus, unless the School receives prior written notice to the contrary. The Student and family will both be held responsible and accountable for disrespectful/abusive behavior by any family member at any DePaul Catholic sponsored event.

- The undersigned hereby grant permission for DePaul Catholic High School to photograph, tape or interview the Student during school or while participating in school activities and to use the likeness for purposes of advertising in publications and the School's website and social media platforms, unless the School is notified to the contrary in writing. The undersigned authorize the use or reproduction by DePaul Catholic High School without compensation. All photos, recordings, and video are the sole property of DePaul Catholic High School. Further, the undersigned permit notification to newspapers or other media of the Student's special recognitions and achievements. The undersigned discharge DePaul Catholic High School from any and all claims arising out of such use, including all claims of libel, and waive the right to inspect or approve any finished materials.
