## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

Because public distribution of tests performed and the related results over information technology could increase the risk to the District's IT security, distribution of that information has been limited to management and the governing body of the District and is kept confidential under RCW 42.56.420.

### About the audit

This report contains the results of our independent accountability audit of Grandview School District No. 200 from September 1, 2014 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements including travel and credit card activity
- Associated Student Body – High School fundraising activities
- Information technology security policies, procedures, practices, and controls protecting financial systems
- Self-insurance through ESD 105 for unemployment compensation
- Open public meetings minutes
- Payroll – leave cash outs and employee contracts
- Procurement of architecture and engineering services
- Fuel usage for the Transportation Department
- Enrollment reporting for – basic, bilingual and special education enrollment

## INFORMATION ABOUT THE DISTRICT

Grandview School District No. 200 serves approximately 3,700 students in Yakima County. The District provides a full range of school programs and services including basic elementary, middle school, high school, vocational education, bilingual education, pupil transportation, food services, special education and remedial and enriched education programs.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's operations. The District's annual expenses were \$39.9 million, \$42.4 million and \$44.4 million in fiscal years 2015, 2016 and 2017, respectively.
