# Confidentiality and Public Information

- Generally, security documents, records, and information reviewed by the committee or discussion of the documents and records should **remain confidential**.
- Texas Education Code section 37.2071(i) makes any document or information collected, developed, or produced during the review and verification of a multi-hazard EOP not subject to disclosure under the Texas Public Information Act (PIA).
- Texas Education Code section 37.108(c-1) provides that any document or information collected, developed, or produced during a safety and security audit conducted under the provision requiring regular safety and security audits of a district's facilities is confidential and not subject to disclosure under the Texas Public Information Act (PIA).
- Access to documents and records by committee members are to be confidentiality protected and not shared with the public. **Any security documents, records, or information shall only be released by the District with permission from the Texas Attorney General.**

# Review from Fall Meeting

- Goals-**
1. Set the expectations for the Security Department.
  2. Participate in the development and implementation of the district's emergency plans.
  3. Address any security concerns within the district.
  4. Review each report the district submits to the TxSSC.
  5. Consult with local law enforcement on how to increase their presence in our campuses.
  6. Periodically providing recommendations to the Board and Superintendent regarding updating the district multi-hazard emergency operations plan, accordance with established best practices.

**Mission Statement** - The mission of the Committee is to provide the most safe and secure environment for CFBISD staff and students by providing stakeholder perspective through communication, collaboration, and recommendations.

**Sentinel of Safety** - This is a new (optional) program for campuses. To be considered for the award, campuses must be in minimal compliance for safety drills, must pass their Intruder Assessment conducted by Region 10, and must complete any safety related project. Campuses can submit [this form](#) with information about their project.

# Upcoming Projects

1. K9's through Interquest (in progress)
  - Random, 30 minute window
  - Survey in June for dates that you want to exclude for NEXT school year
  
2. Vape Sensors
  - Secondary only, installed this summer
  - Will increase discipline, consistent
  - How many per campus?
  - Placement in campus



# Role of Security Officers

- Role will be changing next year
- They will take control of running drills for next year
- They are observe and report (civilians, no weapons, no expectation to intervene with criminal activity)
- Will take ownership of all emergency planning, but will need collaboration with Admin team
- Absolutely no traffic direction in streets; jurisdiction limited to campuses
- Primary role is to be out in the hallways making connections and building relationships with students AND staff
- Camera use
- Principals received [this link](#) earlier to assist with evaluations for security officers (Due April 7)

# Multi-Hazard EOP (MHEOP) Update

- Completely rewrote MHEOP in 2 weeks.
- Submitted to TxSSC in March 15, and was approved on March 20!!
- This Committee is required to review and approve the plan prior to Board accepting it
- Expect an additional meeting (virtual??) with a link to review prior to the additional meeting
