3.        Bids, to receive consideration, must be received prior to the time designated in this invitation, and none will be accepted thereafter.
4.        Bid forms must be signed by either an officer or an agent of the building firm who is authorized to legally bind the firm.
5.        The Board Of Education reserves the right to waive defects and informalities in proposals, to reject any or all proposals, or to accept any proposal as may be deemed to its interest, and to award by item, combination of items or lot.
6.        All bids shall be effective from date of opening unless otherwise specified in special conditions of bidding, and no bid may be withdrawn prior to that time.
7.        Manufacturer's catalogue numbers, trade names, etc., where shown herein for descriptive purposes to guide the bidder in interpreting the standard of quality, design and performance desired, and shall not be construed to exclude proposals based in furnishing other types of materials or service. However, any substitution or departure proposed by bidder must be clearly noted and described; otherwise, it will be understood that bidder intends to supply items specifically mentioned in the bid invitation.

## PROHIBITION AGAINST CONFLICTS OF INTEREST, GRATUITIES AND KICKBACKS

Any employee or any official of the Boyd County Board of Education of Ashland, Kentucky, elective or appointive, who shall take, receive, or offer to take or receive, whether directly or indirectly, any rebate, percentage or contract money, or other thing of value, as an inducement or intended inducement, in the procurement of business, or the giving of business for, or to, or from any person, partnership, firm or corporation, offering, bidding for, or in open market seeking to make sales to the Boyd County Board of Education of Boyd County, Kentucky shall be deemed guilty of a felony and upon conviction such person or persons shall be punished by a fine not to exceed five thousand dollars (\$5,000.00) or by imprisonment in the penitentiary for not more than ten (10) years or both so fined and imprisoned in the discretion of the jury.

Every person, firm, or corporation offering to make, or pay, or give, any rebate percentage of contract money or any other thing of value, as an inducement or intended inducement in the procurement of business, or the giving of business to nay employee or to any official of the Boyd County Board of Education of Boyd County, Kentucky, elective or appointive, in his efforts to bid or offer for sale, or to seek in the open market, shall be deemed guilty of a felony and shall be punished by a fine not to exceed five thousand dollars (\$5,000.00) or by imprisonment in the penitentiary for not more than ten (10) years or both so fined and imprisoned in the discretion of the jury.
