WHEREAS, the Board of Education has reviewed the description and scope of work for the proposed capital construction improvement involving the renovations work at the Robert M. Finley Middle School; and

WHEREAS, the Board of Education has reviewed and evaluated the impact of the Robert M. Finley Middle School project under construction; and after review, determined that this capital project is a routine activity of an education institution and shall have no significant environmental impact; and

BE IT HEREBY RESOLVED, that upon recommendation of the Superintendent of Schools, the proposed Robert M. Finley Middle School capital improvement project is determined to be a Type II Action with a Negative Declaration pursuant to 6 NYSCRR 617.5 (c)(8); and, therefore, the SEQRA review is complete.
