# Glen Cove City School District - Board of Education - Brief of Meeting Meeting Date: April 27, 2009

**NOTE:** A moment of silence was observed in memory of **James Brennan** a former assistant principal at Glen Cove High School.

## Presentation to the Board:

- Poetry Month Celebration: To commemorate this celebration, students from the elementary schools and the middle school were introduced and given the opportunity to deliver readings of their favorite poems several of which were written by the students. Handouts of poems (to be used as "pocket poems") and descriptions of the categories of poetry were distributed to all in attendance.
- Internet Radio Station: Several students participated in a live interview session on the newly established, student-run internet radio station with call letters BHRD ("be heard"). The presentation and interview session were hosted by Ms. Martinez and Mr. Barry, who both serve as advisors to the students. The station is located within the high school library and has become a popular venue and attraction for the students. The students and advisors expressed their deep appreciation to the Board and all members of the District's staff who participated in the realization of this internet radio station.
- Contingency Budget Review: Mr. Wurtz delivered a presentation that defined the terms and outlined the computations associated with developing a contingent budget. If required, the contingent budget for the 2009-2010 academic year will result in a 5.35 percent year-to-year, budget-to-budget increase, and a 7.69 percent increase in the tax levy from the current year's budget.

#### **Superintendent's Report:**

- The High School roof replacement project is progressing quickly towards completion. It is anticipated that the project will be completed by June 1. The new roof will feature tapered insulation and will provide improved drainage, new brickwork to ensure proper weeping action and improved insulation efficiency.
- State and County officials are monitoring the situation associated with the recent cases of Swine Flu. The District's faculty is on alert for detecting students with flu symptoms and reporting such cases to the Nassau County Health Office.
- A review of the High School Track project will be a subject of discussion at the next meeting of the Board, scheduled for May 4<sup>th</sup>. A presentation of the project, that is scheduled to begin after the lacrosse season, will be delivered by an architect involved in the project. It is anticipated that a representative from General Electric will also be in attendance to address questions associated with the lighting plans for the track. Neighbors bordering near the track will be invited to attend this meeting. A Board policy will be written concerning the lighting and use of the track by individuals and groups other than those directly associated with the District.
- A track meet event, hosted by Saint Patrick's C.Y.O. was successfully carried out last weekend on the current track, which was patched-repaired. Ten of the District's students volunteered to facilitate the track meet and approximately 1300 individuals attended and participated in this event. The organizers of the event expressed their appreciation for the use of the current facility and indicated that they look forward to repeating this event on the new track next year.

<u>Open Session:</u> During the open sessions the public had an opportunity to ask questions or make comments with regard to items on the agenda as well as any items of their choosing.
