

- Item No. 589: Moved by Mr. Torres and seconded by Mr. Formino to approve Del Valle's fifth-grade class field trip to San Diego on Thursday, February 23, 1978, subject to the Goodal Bus Lines being able to provide a qualified bus and certified driver. 5 Yes.
- Item No. 590: Moved by Mr. Formino and seconded by Mrs. Arneson to approve additional economic benefits for 1977-78 for non-bargaining unit personnel as follows: 1. Management, supervisory, and confidential employees to receive a 1 percent salary increase, effective July 1, 1977. 2. Adult Education teachers under 8 hours to receive a 1 percent salary increase, effective February 1, 1978. 3. Noon aides salary increased from \$2.96/hour to \$3.00/hour, effective February 1, 1978. 4.
