Stakeholder and community engagement has been a key component when it comes to Guajome Schools being able to effectively navigate the pandemic. Many of the components of our ESSER III Expenditure Plan are a result of multiple surveys, phone calls, public hearings, and other means of communication throughout the past eighteen months. This feedback helped us develop our Learning Continuity and Attendance Plan and our Local Control and Accountability Plan. In addition, the feedback helped to inform us learn how we could provide a better virtual learning environment for our students, and when we returned to campus, how we could provide a safe and effective learning experience for all of our stakeholders. Most recently, at the end of August, we sent out a survey that specifically addressed ESSER III funding and the areas of Providing continuous and safe in person learning alongside of addressing lost instructional time. We had nearly 500 students, staff, and parents respond to the survey, which in turn help to inform our process moving forward.

A description of how the development of the plan was influenced by community input.

Community input played a significant process in helping us to develop our plan for ESSER III expenditures. Stakeholder feedback that we have received was heavily focused on providing a safe and consistent learning environment for all of our stakeholders. While addressing academic needs was important to our stakeholders, there was a strong understanding within the feedback we have received that mental health supports were extremely necessary to help move the organization forward. This led to the hiring of a full time social worker at our school. Along with these supports, stakeholders prioritized the need for ELA and math support which led us to hiring additional staff to provide academic interventions in those areas. Lastly, there was significant importance placed on providing a safe learning environment for our students, and as a result, there will be a significant investment in air filtration systems, PPE, and additional security to provide for a safe learning environment.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
