Course Description

This course is an examination of the people, events, and movements which have significantly contributed to the nation's political, economic, and social history. Importance will focus on students using their critical and analytical thinking skills. This course is an examination of the people, events, and movements which have been significant in America's political, economic, and social development. U.S. History I Honors will explore America's past from the *Articles of Confederation* up to and including America's role in the latter part of the 19th century. Students will gain an appreciation of the Founding Fathers, their struggles to form a capitalist and democratic society, and understand how their ideals evolved to shape the American experience. Students will explore topics including: Confederation to Constitution, Launching a New Republic, the Jefferson Era, National and Regional Growth, the Age of Jackson, Manifest Destiny, a Spirit of Change and Enlightenment, the Nation Breaking Apart, the American Civil War, Reconstruction, Industrialization and the Birth of the Middle Class.
