STUDENTS MUST WALK AND NOT RIDE THEIR BIKES ONCE ON SCHOOL GROUNDS. **CALIFORNIA LAW REQUIRES BICYCLE RIDERS UNDER THE AGE OF 18 TO WEAR A SAFETY HELMET.**



I UNDERSTAND THAT THE BIKE CAN BE CONFISCATED BY SCHOOL PERSONNEL IF MY CHILD RIDES ON THE SCHOOL GROUNDS OR IS SEEN RIDING HIS/HER BIKE WITHOUT A HELMET; IN SUCH AN EVENT, I WILL BE REQUIRED TO COME TO THE OFFICE AND CLAIM THE BICYCLE AND/OR HELMET.
