### IC 20-24-8-5 — Charter Schools **Applicable Statutes, Rules & Guidelines**

- (1) IC 5-11-1-9 (required audits by the state board of accounts).

- Have legal settlement in Indiana;

- Be between the ages of 5 and 22 no later than August 1 of the school year;
- Live in a household at or below the household income limits;

# Choice Scholarship (Voucher) Amount

The scholarship is the **lesser** of three amounts:

- 1) Tuition and fees;
- 2) \$4,500 for grades 1-8; or,
- 3) An amount based off the per-student state funding for the student's school corporation of residence, determined as follows:
  - 90% of funding formula amount if the family income falls within 100% of Reduced Lunch eligibility (\$40,820 for a family of four)
  - 50% of formula amount if family income is above 100% but under 150% of Reduced Lunch eligibility (approx. \$62,021 for a family of four)



### Voucher Statistics 2011-12

- The largest percentage of private/parochial schools in state is within FWCS boundaries (9,090 of 75,700)
- The largest number of vouchers provided in any one district were in FWCS boundaries (392)
- Promotion of vouchers will result in more losses to FWCS – if 500 more, revenue loss is \$3 million

# School Scholarship Tax Credit Program (not Voucher)

- Funding comes from private, charitable donations to qualified scholarship granting organizations (SGOs). Donors (individuals or corporations) will be eligible to take advantage of a 50% credit against their state tax liability for contributions made to an SGO. No limits on the size of qualifying contribution to an SGO, the entire tax credit program has a limit of \$5 million in credits per state fiscal. This permits up to \$10 million in donations and scholarships.
- An SGO is eligible for certification if it is exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code and is organized at least in part to grant school scholarships. An SGO cannot limit the scholarships it provides under the program to children attending a particular school. Parents apply for scholarships from a certified SGO, which may establish certain requirements for the scholarships they provide. A student is eligible to apply for the program if the student is a member of a household with an annual income of not more than two hundred percent (200%) of the amount required to qualify for the federal free or reduced price lunch program. To qualify for an initial scholarship, eligible students must have been enrolled in a public school the prior year or must be entering Kindergarten.
- A participating school is a public or nonpublic school to which an eligible student is required to pay tuition or transfer tuition to attend and which voluntarily agrees to enroll the student. Participating schools must be accredited by the Indiana State Board of Education or a state, national or regional accreditation organization and must administer the ISTEP+ or another nationally-recognized norm-referenced test.










### **Current Student Population Density**






### School Age Population Change
