Budget

- Revenue

Revenue

- 2010 Statewide Revenue cut \$300 million
 - Permanent cut per Governor
- 2011 Revenue Debate in Indianapolis
 - Is new 2010 starting point? (assumption used by FWCS in projections)
 - Is original 2011 budget still in place until formally cut?
 - When will we know?
 - Possibly at statewide budget meeting June 16



Circuit Breaker

(CPF, Transportation, Racial Balance, Debt)

2009

- Very few homesteads receive credit
- Loss to FWCS \$1.1 million (mostly rentals)

2010

- 40% of homesteads receive credit in Allen County
- Depends on location of property. The higher the tax rate, the more likely to receive credit
- Loss to FWCS \$4.1 million with \$1.5 million relief from state, net \$2.6 million

2011

Same as 2010, but no state relief to schools



Circuit Breaker

Referendum on November Ballot

The Circuit Breaker creates inequitable funding in Indiana:

- Districts located in urban areas with more overlapping taxing units (City, Library, Airport, etc.) have high property tax rates
- Higher tax rates cause the Circuit Breaker to be reached more often
- Per pupil loss ranges from zero to \$1,011
- 76% have loss of \$100 or less per pupil
- FWCS loss about \$140 per pupil, 3.8% affected budget
- NWAC & SWAC loss higher than FWCS

 - Partnership (HOPE, FWCS, IDOE, ...)
- Reading First
 - Professional Development
 - 6 Reading First Schools only

Student Transition

Pleasant Center

- Open House for Pleasant Center Families @ Harrison Hill, Maplewood & Waynedale – May 12, 6:00pm
 - Tour new school and visit with teachers and PTA members
- Student Visitation to New Schools (Harrison Hill, Maplewood, Scott & Waynedale) – May 17, 9:30am
 - Students will take a field trip to their new school and have an opportunity to participate in a tour, visit with prospective friends, and meet new teachers
- Registration Day Aug. 6, 8-1:00 and Aug. 9, 12-7:00
 - A special orientation will be held for Pleasant Center families to provide additional information and to answer questions. Each school will provide specific date and time for this orientation in its registration letter.



Student Transition

Elmhurst

- Parent meetings on March 10, 23 & 25.
- A high school **mini-showcase** was held @ Elmhurst regarding course selections, extra-curricular, and summer camps.
- Teams of counselors from each high school met one-on-one with each Elmhurst student to develop their schedule for next year.
- **IDT process extended**, lottery held on April 12, and families have until April 30 to appeal.
- **Orientation** for 9th-12th graders will be held @ each LEAD school.
- Extended year opportunity for students who need a prerequisite course to meet Honors, IB, or Technical Honors diploma requirements for graduation in 2011.
- LEAD principals are planning additional community outreach.



Race to the Top Federal

- Phase I Grant Applications
 - 40 states applied
 - 16 finalists
- Awards granted to only 2 states
 - Delaware
 - Tennessee
- Round 2 Applications due June 1



Fast Forward State

Round 2

- Indiana may not be applying
- IDOE intends to implement their plan without Federal support
- FWCS proceeding with our work plan under the same assumption

It's the right thing to do.

- Planned "new" staff training for summer

Custodial RFP Process

- Request for Proposals (RFP) have been released
- Proposals due May 10
- Discussions with AFSCME ongoing
- Recommendation to Board in June
- Implementation of changes in July
