

College Park places 2nd at Valley Division Championships; Winning Final Premier Events of the Day in both Men and Women 4x100 Free Relay

College Park swimmers competed against Clayton Valley, Benicia, Alhambra, Concord, Berean and Mt. Diablo schools this weekend in a showdown all the way through the last two events.

Anna Gornyitzki lead the team in scoring 40 points; winning both her individual events; 200 free, 2:06.07 and 100

free, 56.60. Anna along with teammates Molly Ostrowski, Lucy Galbraith and Elsa Horciza won the 4x100 free relay with a time of 3:55.78 Molly scored 32 points taking 3rd in the 200 and 100 free. Other strong swims came from McKenna Gross placing 3rd in the 100 breast with a time of 1:15.27 dropping over 6 seconds from time trials and Madison Branse placing 3rd in the 100 fly with a time of 1:05.46. Outstanding time drop came from Makayla Karst placing 6th in the 500 free dropping 20 seconds.

Leading the men in breakthrough swimming this weekend was Jackson Barnacal scoring 33 points, winning the 100 backstroke with a time of 59.14, and leading his teammates to cliniching a win in the 4x100 free relay with teammates James Malliore, Matt Hutchinson, and Devin Purwal just touching out Clayton Valley. Devin Purewal scored 30 points placing 4th in both the 100 fly; 55.74, and 100 free; 50.29.

Matt Hutchinson scored 27 points placing 5th just behind Purewal with a time of 50.68, and 6th in the 100 fly with a time of 56.18.

"I am so proud of the entire team, said Coach Vicky Dewey." Everyone demonstrated and executed all the race details we have been working on during our short season, but beyond swimming they all had grace and poise in the midst of fierce competition."

Other highlights came from breakout swims in addition to Jackson Barnacal: Adriahna Shirley, Audrey Hoover, Joe Corona, Katelyn Crossman, William Davis, Kaleena Kardell, Quinn Luthropp.

Also, a big part of bringing the team together has been from the outstanding leadership from Rosy Deilke. Throughout the entire season she contributed to our new creation of "Positive Vibrationz;" our student run social media on Google classroom offering inspirational messages and contributions from any team member giving our athletes ownership with promoting the well being of swimming and our program at CP. Under the guidance from Coach Ivan Korelov, she has been a great source of calm, motivation, inspiration and dedication in a positive approach to a social media platform.

Recording of Classroom Lessons by Students, Parents or Teachers

There have been many questions regarding recordings of online sessions, so I want to share the guidelines we are following at College Park.



- Video recordings of classroom instruction qualify as "education records" under the Family Educational Rights Privacy Act, and as such are protected by state and Federal privacy laws. The following rules apply:
- Recordings by teachers of classroom instruction for distribution to students for educational purposes are permitted by FERPA. When used for an educational purpose, recordings of a classroom by a teacher are not considered an "educational record."
- Recordings by students of lessons for educational purposes are permitted but only if expressly authorized by the teacher. Under California Education Code Section 51512 it is illegal for any person including the student - to record what is happening in the classroom without the consent of the teacher.
- Recordings by parents of lessons for widespread distribution, or for virtually any use, are not permitted by the California Education Code. Again, it is illegal

for a parent to record classroom instruction without the expressed and written consent of the teacher, and such recording may not be distributed to third parties (such as in social media) under FERPA. See Ed. Code Section 51512.

- A = Absent (none of the above engagement)

Support Staff Code:

• 6 = Support Service Access: Speech Therapy, OT, PT, Counseling

Distance Learning Student Expectations & Protocols for Online Meetings

- Students must login using their MUDSD.Net email account
- Log-on to Zoom/Google Meet five minutes prior to class starting
- Have First and Last name correctly spelled on your Zoom/Google Meet window
- Keep cameras on (if possible) and Microphones on Mute unless speaking to teacher or as directed by teacher.
- Students should be in appropriate school attire during online meetings
