**AN ORDINANCE SETTING THE 2019 TAX RATE FOR THE
BROWNSBORO INDEPENDENT SCHOOL DISTRICT**

WHEREAS, it was necessary to set and adopt a tax rate in order to allow the Brownsboro Independent School District to carry out its corporate purposes, objectives, maintenance, and operation; and

WHEREAS, the governing body gave notice of the date, time, and place of the meeting at which it would vote on the proposed tax rate for the Brownsboro Independent School District in accordance with the law and, after all requirements for consideration and adoption of a tax rate had been met, the Board of Trustees did hold such meeting to vote on the tax rate; and

WHEREAS, the Board of Trustees of the Brownsboro Independent School District did, on the 19th day of August, 2019, then and there adopt the M&O tax rate of \$1.0683 and the I&S tax rate of \$0.3100 for a total tax rate of \$1.3783 per \$100 valuation on taxable properties within the Brownsboro Independent School District by record vote of 7 votes in favor, 0 votes opposed, and 0 abstentions; and

WHEREAS, it was, and is, in the public interest and welfare to adopt such tax rate for the purpose of carrying out the corporate purposes, objectives, maintenance, and operation of the Brownsboro Independent School District.

NOW, THEREFORE, BE IT ORDAINED AND ORDERED by the Board of Trustees of the Brownsboro Independent School District that

We, the Board of Trustees of the Brownsboro Independent School District, do hereby adopt the tax rate per \$100 valuation and levy taxes on all taxable property located within Brownsboro ISD for the 2019 tax year as follows:




